## ORDINANCE NO. \_\_\_671

AN ORDINANCE AMENDING CHAPTER 20 BUILDING, SECTION 20.01(e), MUNICIPAL CODE OF THE CITY OF LEROY, ILLINOIS 1975 (AS AMENDED)

WHEREAS, the Mayor and City Council of the City of LeRoy, McLean County, Illinois, an Illinois municipal corporation, have determined that it is in the best interests of the City and its residents that certain amendments be made to the building code of the City of LeRoy, and

WHEREAS, one or more hearings have been held by the Zoning Board of Appeals of the City of LeRoy to consider the proposed text amendments as set forth hereinafter, due notice having been given for any and all said hearings,

NOW, THEREFORE, BE IT ORDAINED, by the City Council of the City of LeRoy, Illinois, in lawful meeting assembled, as follows:

Section 1. Chapter 20 Building, Municipal Code of the City of LeRoy, Illinois 1975 (as amended), Section 20.01 (e) Structure., is hereby amended by addition of the following words and figures in parenthesis after the word "fences" and before the comma appearing after the word "fences":

(portable-type fencing capable of enclosing an area of up to 100 square feet shall not be considered a "fence" or "structure")

Section 2. All ordinances, or parts thereof, and all resolutions, or parts thereof, in conflict with this ordinance shall be and the same are hereby repealed to the extent of such conflict, and this ordinance shall be in full force and effect as set forth hereafter.

Section 3. This ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form, as required by law.
