ORDINANCE NO. 688

AN ORDINANCE AMENDING SECTIONS 13, 14 AND 15 OF CHAPTER 20, BUILDING CODE, OF THE MUNICIPAL CODE, CITY OF LEROY, ILLINOIS, 1975 (as amended)

WHEREAS, the Mayor and City Council of the City of LeRoy, McLean County, Illinois, an Illinois municipal corporation, have determined that a new National Building Officials and Code Administrators International, Inc., recommended code (1996) ("BOCA Code"), a new Council of American Building Officials and Code Administrators International, Inc., recommended one and two-family dwelling code (1995) ("CABO Code"), and a new recommended National Electric Code (1996) have been prepared and are now available for use and adoption by municipal governments in the United States of America and in the State of Illinois; and

WHEREAS, the Mayor and City Council of the City of LeRoy believe it is in the best interests of the City and of its residents that the changes and additions to the various stated building codes and electrical code be adopted for use in the City of LeRoy,

NOW, THEREFORE, BE IT ORDAINED, by the City Council of the City of LeRoy, Illinois, in lawful meeting assembled, as follows:

Section 1. The number "1993" in the section heading and wherever it appears in the body of Section 13, Chapter 20, Building Code, Municipal Code of the City of LeRoy, Illinois, 1975 (as amended), is hereby deleted and the number "1996" is hereby substituted for the same in amendment of said section. It is the intention of the City Council of the City of LeRoy that after the date set forth hereafter as the effective date for use of the BOCA National Building Code/1996, the BOCA National Building Code/1993 will no longer be in use or accepted by the City, except for building permits that have already been approved under the now current building code and for determination of violations for structures for which the construction was complete as of the effective date given hereafter.

Section 2. The number "1992" wherever it appears in the body of Section 14, Chapter 20, Building Code, Municipal Code of the City of LeRoy, Illinois, 1975 (as amended), is hereby deleted and the number "1995" is hereby substituted for the same in amendment of said section. It is the intention of the City Council of the City of LeRoy that after the date set forth hereafter as the effective date for use of the Council of American Building Officials and Code Administrators International, Inc., recommended one and two-family dwelling code/1995, the Council of American Building Officials and Code Administrators International, Inc., recommended one and two-family dwelling code/1992 will no longer be in use or

accepted by the City, except for building permits that have already been approved under the now current building code and for determination of violations for structures for which the construction was complete as of the effective date given hereafter.

Section 3. New Section 15.5, Chapter 20, Building Code, Municipal Code of the CIty of LeRoy, Illinois, 1975 (as amended), is hereby adopted in words and figures as follows:

and the whole thereof, hereinafter referred to as "NEC," or sometimes referrred to as "electric code," save and except such portions as are deleted, modified, or amended in Article VI of this chapter. The provisions of said Code are hereby adopted and incorporated herein as fully as if set out at length and the provisions thereof shall be controlling in regard to all buildings and structures within the corporate limits of the City, except as provided in section 12 of this Article.

- <u>Section 4</u>. None of the aforesaid revisions of national recommended codes shall be considered enforceable until September 1, 1996.
- <u>Section 5</u>. All ordinances, or parts thereof, and resolutions, or parts thereof, in conflict with this ordinance shall be and the same are hereby repealed to the extent of such conflict, and this ordinance shall be in full force and effect as set forth hereafter.
- Section 6. Nothing in this ordinance hereby adopted shall be construed to affect any suit or proceeding pending in any court, or any rights acquired, or liability incurred, or any cause or causes of action acquired or existing, under any act or ordinance hereby repealed as cited in Section 3 of this ordinance; nor shall any just or legal right or remedy of any character be lost, impaired or affected by this ordinance.
- <u>Section 7</u>. This ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form, as required by law.
