## ORDINANCE NO. 407

AN ORDINANCE AMENDING CHAPTER 3, CITY ADMINISTRATION, MUNICIPAL CODE OF Leroy, ILLINOIS (1975), AND ESTABLISHING A COMMITTEE FOR COMMUNITY ACTIVITIES AND SPECIAL EVENTS.

WHEREAS the City Council of the City of LeRoy, McLean County, Illinois, finds it necessary and appropriate to establish a committee for community activities and special events, and that the creation of such committee is in the best interests of the City of LeRoy and its residents, and

WHEREAS it is the intent of the City Council that in establishing said committee and appointing representatives of various local organizations to said committee that in so doing the organizations represented by the representatives on the aforesaid committee shall be afforded liability insurance protection for activities held on City streets or other City property, insofar as such liability protection may be afforded through the risk management association and insurance carriers contracted with by the City of LeRoy,

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of LeRoy, Illinois, in lawful meeting essembled, as follows:

Section I. Chapter 3, City Administration, of the Municipal Count of LeRoy, Illinois 1975, (as amended), is hereby amended by addition of new Section 3.12 in words as follows:

3.12 COMMITTEE FOR COMMUNITY ACTIVITIES AND SPECIAL EVENTS. At the beginning of each municipal fiscal year, the Mayor of the City shall appoint representatives from each charitable organization, civic organization, service organization, and other similar organizations located in the City of LeRoy to the Committee for Community Activities and Special Events for a one year term. The committee shall hold meetings at such times and places during the fiscal year of the City as may be appropriate. The advice and consent of the City Council shall be required in order to confirm and finalize the appointments to the aforesaid committee. When appointing the members of the committee, the Mayor shall appoint one of the committee members Chairman of the committee.

- (a). The duties and responsibilities of the aforesaid committee shall be to recommend to the Mayor and City Council policy and guidelines in all matters pertaining to the establishment and operation of community activities and special events from time to time insofar as the same may be conducted upon City property, including City streets and parking lots.
- (b). The respective organizations shall be asked to nominate one of their officers or other members to act as a representative, if appointed by the Mayor and confirmed by the City Council, to act as a member of the aforesaid committee.

SECTION 2. This ordinance shall be in full force and effect ten days after its passage and publication in pamphlet form as required by law.
