AN ORDINANCE APPROVING AGREEMENT WITH CONSULTANTS FOR CITY OF LEROY FIRST TAX INCREMENT FINANCE DISTRICT

WHEREAS, the Mayor and City Council of the City of LeRoy, McLean County, Illinois, an Illinois municipal corporation, have reviewed the proposed CONSULTANTS AGREEMENT as set forth in Exhibit "A" attached to this ordinance, regarding consulting services to be provided in connection with the City of LeRoy First Tax Increment Finance District; and

Dear Mayor Davis:

Pursuant to our recent discussions, Kane, McKenna and Associates, Inc. offers this proposal to continue to provide services to the City of LeRoy (the "CITY") with regard to the CITY's Tax Increment Finance (TIF) districts.

The CONSULTANT proposes to provide the CITY with services related to the ongoing administration of the CITY's TIF districts. The CONSULTANT also proposes to provide services, as required, to assist the CITY to review and structure incentive packages for new private development proposals.

The CONSULTANT will provide servies including:

- I. Assist the CITY in meeting all State of Illinois regulations and requirements pertaining to the establishment and operation of the CITY's state sales tax TIF district, including:
 - A. Submission of proper documentation for any revisions to the TIF district that might be undertaken from time to time by the CITY.
 - B. Preparation and submission of all certifications and opinions from the CITY's counsel required in connection with the TIF reporting process.
 - C. Review for submission the required list of businesses within the TIF district.

These services will be conducted in a manner geared to protect the status of the CITY's state sales tax TIF.

- II. Prepare a report on the outstanding obligations under the various redevelopment agreements entered into between the CITY and private redevelopers.
 - A. Work with private redevelopers to obtain documentation of eligible costs and the annual amount of incremental sales and property taxes generated by the development projects.
 - B. Prepare a report to the CITY showing the amount due under each outstanding redevelopment agreement.
- III. Advise the CITY, as called upon, regarding the operation and management of the TIF district in a manner consistent with state law, services include:
 - A. Evaluation of various strategies aimed at achieving the CITY's goals of packaging public funding for certain public improvements and/or to induce private investment within the CITY's TIF districts.
 - B. Advise the CITY regarding the most economical and efficient methods for financing public improvements and/or development inducement packages as a means to promote redevelopment within the TIF districts.
 - C. Analyze, for the CITY, developer or corporate requests for TIF/public assistance and make recommendations regarding their merit. This analysis will evaluate the need for public assistance, the amount, if any, that should be considered, the projected amount of incremental taxes the project might generate, and the preparation of alternative public financing structures available to the CITY.

COMPENSATION FOR SERVICES

The CITY will be billed monthly for services provided by the CONSULTANT* according to the following hourly rates:

Personnel	Hourly Rates
Principal	\$85.00/Hour
Officers	\$75.00/Hour
Associate	\$65.00/Hour
Administrative	\$15.00/Hour

All hourly fees are subject to an overhead rate of 75% to cover all other expenses of doing business including rent and utilities, computers and equipment, employee fringe benefits, supplies and postage. Expenses for travel outside the Chicago metropolitan area, if any, will be billed separately.

The CONSULTANT shall have the right to retain any subcontractors considered necessary to expedite the services described herein, provided that such subcontractors shall be paid solely from the CONSULTANT's compensation as set forth above and the CITY shall have no responsibility for payment to such subcontractors retained by the CONSULTANT.

This Agreement shall expire one year from the date of authorization by the CITY. All information developed by the CONSULTANT on behalf of the CITY will remain the property of the CITY and must be returned by the CONSULTANT upon the expiration of this Agreement if the Agreement is not extended.

- * The billing schedule shall be subject, however, to the following limits provided, however, that the City understands that the time and costs of CONSULTANT's services is similarly limited:
 - a) Payments shall not exceed \$3,000.00 for services rendered under Section I;
 - Payments shall not exceed \$10,000.00 for services rendered under Section II;
 and
 - c) Payments shall not exceed \$10,000.00 for services rendered under Section III
