AN ORDINANCE APPROVING FURTHER AMENDMENT OF MODIFICATION OF A REDEVELOPMENT AGREEMENT FOR THE LE ROY FIRST TAX INCREMENT FINANCING DISTRICT INVOLVING THE BRADLEY APARTMENTS PROJECT

WHEREAS, the City of LeRoy entered into a tax increment redevelopment agreement dated December 16, 1991, regarding that real estate described in the aforesaid agreement, said agreement having been entered into between the City of LeRoy and National Urban Development Corporation, an Illinois corporation; and

WHEREAS, said agreement was modified or amended by the parties or their successors in interest by agreement entered into between the parties on or about January 13, 1994; and

WHEREAS, the successor in interest to National Urban Development Corporation was Old Second National Bank of Aurora, as trustee under the provisions of a trust agreement dated the 30th day of December, 1992, and known as Trust No. 5510; and

WHEREAS, the trust owning the previously described real estate has been terminated and the ownership of that real estate has been transferred to LeRoy Properties Land Trust No. 1997, c/o Mike Janko at 2777 Finley Road, Suite 21, Downers Grove, Illinois 60515; and

WHEREAS, Janko of LeRoy, Inc., is apparently the beneficial owner of the aforesaid Land Trust No. 1997; and

WHEREAS, future checks are not to be sent to Old Second National Bank of Aurora, as it no longer has any involvement with the previously described property nor with the previously described redevelopment agreement; and

WHEREAS, the Mayor and City Council of the City of LeRoy, McLean County, Illinois, an Illinois municipal corporation, find that it is in the best interests of the city and its residents that the aforesaid tax increment redevelopment agreement be further modified,

NOW, THEREFORE, BE IT ORDAINED:

<u>Section 1</u>: The City Council hereby approves modification of the modified contract by addition of the contract amendment in the form attached hereto as *Exhibit A*, which is incorporated herein by reference.

Section 2: The Mayor and City Clerk of the City of LeRoy are hereby directed and authorized to execute the amendment modifying an agreement entered into with Old Second National Bank of Aurora (Exhibit A), conforming with the copy attached hereto, and the aforesaid city officers shall execute several copies of said amendment as may reasonably be required, retaining one or more signed copies of the amending agreement for the city, as may be appropriate.

<u>Section 3</u>: This ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as required by law.
