

ORDINANCE NO. 345

AN ORDINANCE CORRECTING ORDINANCE NO. 326

WHEREAS, the City of LeRoy, McLean County, Illinois, an Illinois municipal corporation, approved a redevelopment plan and redevelopment project for LeRoy Tax Increment Financing District II, by Ordinance No. 326 adopted by the Mayor and City Council of the City of LeRoy on August 1, 1988, and

WHEREAS, Exhibit "A" to the aforesaid ordinance included a description of the real estate to be included within said Tax Increment Financing District, and as part of the legal description also appended thereto was a copy of a map showing the intended boundaries of the aforesaid Tax Increment Financing Redevelopment project area, and which map, due to the scale of same, appears to have, at least in some copies of said map, inadvertently omitted Lot 15 in Bel Vue Subdivision, and

WHEREAS, the Mayor and City Council of the City of LeRoy hereby find that said omission was not intentional, but was merely a scrivener's error,

NOW, THEREFORE, BE IT ORDAINED by the Mayor and City Council of the City of LeRoy, Illinois, in lawful meeting assembled, as follows:

Section 1. That the legal description appended hereto as Exhibit "A" is determined to be the correct legal description for the property to be included in LeRoy Tax Increment Financing District II.

Section 2. That the map appended hereto as Exhibit "A-1" is determined to be the correct outline of the boundaries of the aforesaid Tax Increment Financing District and that said map and copies thereof shall be substituted as necessary and appended to Ordinance No. 326 in the official records of the City of LeRoy.

Section 3. That the City Clerk is hereby directed to cause a certified copy of this ordinance to be filed with the County Clerk of McLean County, Illinois, as soon after the passage and approval of this ordinance as may be practical.

Section 4. That all other copies of the map set forth in Exhibit "A-1" in the official records of the City of LeRoy, and relating to LeRoy Tax Increment Financing District II are hereby deemed to be corrected to the extent that Lot 15 in Bel Vue Subdivision of the City of LeRoy, McLean County, Illinois, is shown as being within the boundaries of LeRoy Tax Increment Financing District II.

Section 5. This ordinance shall be in full force and effect from and after its passage by the City Council of the City of LeRoy, Illinois, approval by the Mayor thereof, and publication in pamphlet form as required by law.






