AN ORDINANCE APPROVING AMENDMENT OF THEREDEVELOPMENT PLAN AND REDEVELOPMENT PROJECT FOR LEROY TAX INCREMENT FINANCING DISTRICT II

WHEREAS, the City of LeRoy, Illinois, an Illinois municipal corporation, hereinafter referred to as "CITY," on August 1, 1988, by Ordinance Numbers 326, 327 and 328, all adopted on the aforesaid date, did create and establish An Ordinance Approving Redevelopment Plan and Redevelopment Project for LeRoy Tax Increment Financing District II; and

WHEREAS, CITY desires to pay certain administrative costs associated with the maintenance of the aforesaid tax financing plan and redevelopment district; and,

WHEREAS, the proposed work is within the tax increment redevelopment district, is compatible with the general land use and is consistent with the aforesaid redevelopment plan; and,

WHEREAS, the Annual Appropriation Ordinance for CITY Ordinance Number 402, adopted July 15, 1991, generally provides for such administrative expenses,

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of LeRoy, Illinois, in lawful meeting assembled, as follows:

SECTION 1. The redevelopment plan adopted in accordance with Ordinance Number 326 on August 1, 1988, is hereby amended to provide for the payment of one hundred fifty dollars (\$150.00) per month for the work of the administrative assistant for the City in regard to administrative matters and details attended to from time to time by said assistant in connection with the administration of the aforesaid tax increment financing district, plan and related matters, and that said amount shall be paid retroactive to October 1, 1991, to the aforesaid administrative assistant.

SECTION 2. That the City Clerk of the City of LeRoy, Illinois, is appointed, effective October 1, 1991, as the administrative assistant for the City of LeRoy in regard to LeRoy Tax Increment Financing District II.

SECTION 3. Ordinance 326, adopted August 1, 1988, is hereby further amended, effective October 1, 1991, to provide that the expenses for legal services rendered by the City Attorney shall be paid from the five percent (5%) portion of the increments received from time to time and retained for such purposes, and the amount paid to the administrative assistant as set forth in Section 1 of this Ordinance is also to be expended from the aforesaid five percent (5%) of the increments received from time to time as both amounts (the expenses for legal services rendered by the City Attorney and expenses for the aforesaid administrative assistant) are deemed properly compensable from the portion of the increments retained for such purposes.

SECTION 4. That the appropriation ordinance of the City of LeRoy, Number 402, adopted July 15, 1991, is hereby deemed amended to reflect the changes as aforesaid.

SECTION 5. This ordinance shall be in full force and effect from and after its passage and publication in pamphlet form as required by law.
