AN ORDINANCE AUTHORIZING THE EXECUTION OF AN AGREEMENT DETAILING LOAN TERMS AND CONDITIONS FOR LOAN OF COMMUNITY DEVELOPMENT ACTION GRANT RECEIVED BY CITY OF LEROY TO LEROY AUTO/TRUCK PLAZA.

WHEREAS, the City of LeRoy, Illinois, an Illinois municipal corporation, has been designated the recipient of a Community Development Block Grant under the Illinois Community Development Assistance Program, said Grant being numbered 84-24319, the Grant being administered under the auspices of the Illinois Department of Commerce and Community Affairs for the State of Illinois; and

WHEREAS, in order to complete obtaining said Grant the City of LeRoy must enter into a written agreement with the firm or firms involved in the Community Development Action Program project,

NOW, THEREFORE, BE IT ORDAINED by the Mayor and City Council of the City of LeRoy, Illinois, in lawful meeting assembled:

Section 1. The Mayor and City Clerk of the City of LeRoy, Illinois, are hereby authorized to execute the agreement detailing the loan terms and conditions for the loan of the Community Development Action Program Grant agreed to be given to the City of LeRoy by the State of Illinois through its Department of Commerce and Community Affairs, said Grant being numbered 84-24319, a copy of said agreement being attached hereto as Exhibit A and incorporated herein by reference.

Section 2. Upon execution of said agreement by all parties necessary a fully executed copy shall be promptly submitted to the Department of Commerce and Community Affairs of the State of Illinois.

Section 3. The Mayor and City Clerk of the City of LeRoy, Illinois, are hereby further authorized to prepare and execute any and all other necessary documents required under the previously described agreement for the Community Development Action Program Grant, including floodplain information, letters setting forth priority list of community development and housing needs for 1984, solicitation of a letter from an independent auditor certifying that the City's financial system is adequate for handling transactions and accounting for approved activities funded through the Community Development Assistance Program and a revised activities cost sheet reflecting the \$200,000.00 grant, but not limited to the foregoing described documents or other information.

 $\underline{\text{Section 4}}.$ This ordinance shall be in full force and effect from and after its passage and approval and publication in pamphlet form as required by law.
