ORDINANCE NO. 00-10-03-40

AN ORDINANCE APPROVING AN EXTENSION AND MODIFICATION OF A CONTRACT FOR GARBAGE COLLECTION SERVICES WITH AMERICAN DISPOSAL SERVICES OF BLOOMINGTON-NORMAL

WHEREAS, the Mayor and City Council of the City of LeRoy find that it is in the best interests of the City of LeRoy, McLean County, Illinois, an Illinois municipal corporation, to contract with a private disposal firm to pick up garbage and refuse from the residences and many of the businesses located within the City of LeRoy; and

WHEREAS, the Mayor and City Council of the City of LeRoy find that it is not possible to complete negotiations for a new contract with the company currently providing garbage collection services to the City, before the current contract expires, but that the City and the company currently providing garbage collection services are willing to agree to a modification of the current contract and an extension of that contract, as modified, until and including December 31, 2000,

NOW, THEREFORE, BE IT ORDAINED, by the City Council of the City of LeRoy, Illinois, in lawful meeting assembled, as follows:

Section 1. A copy of the contract currently in force between the City of LeRoy and American Disposal Services of Bloomington-Normal (formerly John Sexton Contractors Company) for garbage collection services is attached hereto as Exhibit A and is incorporated herein by reference. The City Council hereby approves the extension of that contract and all provisions therein until December 31, 2000, with the modification of Section 3, CHARGES FOR SERVICE, of said contract document, sub-section C., which modification is to substitute the amount "\$7.50" per unit for the amount as currently set forth in said contract, "\$7.21" per unit, and with the further modification of the amount "\$9,450.00" per month for the figure "\$9,084.60" per month in the same sub-section C.

Section 2. Acceptance of the modification of the aforesaid contract and extension of the same as being binding upon the parties thereto through and including December 31, 2000, is hereby approved by the City Council and shall be binding upon the City of LeRoy and American Disposal Services of Bloomington-Normal upon acceptance of this ordinance modifying and extending the aforesaid contract in writing by American Disposal, the form of said writing being set forth as Exhibit B, attached to this ordinance and being incorporated herein by reference.

Section 3. This ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as required by law.
