### **ORDINANCE NO. 09-11-02-40**

# AN ORDINANCE AMENDING TITLE FOUR, PUBLIC HEALTH AND SAFETY, CHAPTER 2, GARBAGE AND REFUSE; SECTION 3, LANDFILL CLOSURE; OF THE MUNICIPAL CODE OF THE CITY OF LE ROY, ILLINOIS, 2003 (as amended)

WHEREAS, the Mayor and City Council of the City of Le Roy, McLean County, Illinois, an Illinois municipal corporation, have determined that it is necessary and in the best interest of the City and its residents that the rates for landfill closure required to be provided by the City be increased, said increase to be effective May 1, 2010;

**NOW, THEREFORE, BE IT ORDAINED** by the City Council of the City of Le Roy, in lawful meeting assembled, as follows:

Section 1. That Section 4-2-3 Title Four, Public Health and Safety, Chapter 2, Garbage and Refuse; Section 3, Landfill Closure; Part (A) Closure Requirements; of the Municipal Code of the City of Le Roy, Illinois, 2003 (as amended), are hereby deleted.

Section 2. That Section 4-2-3 Title Four, Public Health and Safety, Chapter 2, Garbage and Refuse; Section 3, Landfill Closure; Part (A) Closure Requirements; of the Municipal Code of the City of Le Roy, Illinois, 2003 (as amended), are hereby adopted in words and figures as follows:

A. Closure Requirements: The anticipated expense to close the landfill will include the following Illinois Environmental Protection Agency mandates: 1) an ongoing monitoring program that will cost approximately forty-five thousand dollars (\$45,000.00) per year; 2) ongoing chemical evaluation that will cost an estimated fifty-five thousand dollars (\$55,000.00) per year; 3) engineering and ongoing mandated responsibilities, approximately (\$39,000.00) per year. The

total estimated cost for the next three years is four hundred seventeen thousand dollars (\$417,000.00);

Section 3. That Section 4-2-3 Title Four, Public Health and Safety, Chapter 2, Garbage and Refuse; Section 3, Landfill Closure; Part (B) Fee; of the Municipal Code of the City of Le Roy, Illinois, 2003 (as amended), are hereby deleted.

Section 4. That Section 4-2-3 Title Four, Public Health and Safety, Chapter 2, Garbage and Refuse; Section 3, Landfill Closure; Part (B) Fee; of the Municipal Code of the City of Le Roy, Illinois, 2003 (as amended), are hereby adopted in words and figures as follows:

B. Fee: All utility customers of the City of Le Roy will be required to pay an eight dollar (\$8.00) per month fee beginning with the first bill prepared after May 1, 2010 for twelve consecutive months; All utility customers of the City of Le Roy will be required to pay an eight dollar (\$8.00) per month fee beginning with the first bill prepared after May 1, 2011 for twelve consecutive months; All utility customers of the City of Le Roy will be required to pay an eight dollar (\$8.00) per month fee beginning with the first bill prepared after May 1, 2012 for twelve consecutive months.
