AN ORDINANCE AMENDING THE MUNICIPAL CODE, LEROY, ILLINOIS 1975, CHAPTER 12, NUISANCES, SECTION 12.09 (a)-(d), "DUMPING AT LANDFILL"

AN ORDINANCE AMENDING THE MUNICIPAL CODE, LeROY, ILLINOIS, 1975, CHAPTER 12, NUISANCES, SECTION 12.09 (a)-(d), "DUMPING AT LANDFILL"

WHEREAS, the City of LeRoy has a city owned Landfill which is maintained for the benefit of the City of LeRoy, and

WHEREAS, various other persons, governmental entities and organizations outside the municipal limits of the City of LeRoy from time to time make application to the city for use of said Landfill, and

WHEREAS, the City Council of the City of LeRoy from time to time may deem it to be in the best interests of the community to allow the use of said Landfill by certain persons and governmental entities outside the municipal limits of the City of LeRoy,

NOW THEREFORE BE IT ORDAINED by the Mayor and City Council of the City of LeRoy, Illinois:

Section 1. That Chapter 12, Section 12.09 of the Municipal Code, LeRoy, Illinois 1975, as amended, Sections (a)-(d), are hereby repealed.

Section 2. That Chapter 12, Section 12.09 of the Municipal Code, LeRoy, Illinois 1975, as amended, is newly enacted to read as follows:

- (a) No dumping of any garbage, refuse, or material shall be made in the City Landfill of LeRoy by any person, organization, business or governmental entity other than regular city employees hauling city garbage, unless by written permit from the Superintendent of Streets, or any other officer appointed by the city and authorized to issue such permit, and then only in such event as said written permit has been previously authorized by action of the city council.
- (b) No person shall be permitted to use the City Landfill unless such person is a resident of the city, unless such material so deposited shall be grown, used, discarded or construed as becoming refuse within the City of LeRoy by the Supervisor of the City Landfill, or unless authorization is given for such dumping upon application to the city council and approval being granted by said city council upon such application.
- (c) There shall be paid to the Superintendent of Streets, or any other officer designated to issue the aforementioned written permit, before the issuance of such written permit, such fee as may be set from time to time by the city council.
- (d) All dumping shall be under the supervision and direction of the Supervisor of the city Landfill, and any non-compliance shall be corrected by the city, and appropriate action, shall be taken for riolation of this Ordinance, including collection by suit against any persons violating the orders of the supervisor.
- (e) Unless another appointment shall be made by the mayor with the advice and consent of the city council from time to time, the Superintendent of Streets from time to time shall also be designated the Supervisor of the City Landfill.

Section 3. That this ordinance shall be in full force and effect after its passage and approval as required by law.
