ORDINANCE ACCEPTING GRANTS OF SEWER EASEMENT.

WHEREAS, the Mayor and City Council of the City of LeRoy, McLean County, Illinois, an Illinois municipal corporation, find it is necessary for the City to expand and renovate certain sections of its sewage collection system, and

WHEREAS, it is necessary to grant certain easements for the constituctor tion of the sewer lines,

GRANT DI SEWER LINE CASLMINI TO MUNICIPALITY

GRANTOR (S), WENDELL CRUMBAUGH, a married man,

of R.R. #1, LeRoy , McLean County, Illinois (hereinafte referred to as GRANTOR), in consideration of ONE BOLLAR (\$1.00) in hand paid and other good and valuable consideration, do/does hereby agree with the CITY OF LEROY, McLean County, Illinois, an Illinois municipal corporation, as follows, and do/does hereby grant to the CITY OF LE ROY, McLean County, Illinois (hereinafter referred to as MUNICIPALITY), a Permanent Easement across the following described premises (hereinafter referred to as the "Easement Premises"):
