AN ORDINANCE AUTHORIZING THE EXECUTION OF AN INTER-GOVERNMENTAL COOPERATION AGREEMENT WITH LEROY EMERGENCY AMBULANCE SERVICE, INC. FOR THE PURCHASE OF RADIO EQUIPMENT AND PROVISION OF DISPATCH SERVICES.

WHEREAS, the Mayor and City Council of the City of LeRoy, have determined that purchase of certain radio equipment would be in the best interests of the residents and citizens of the City of LeRoy, as well as in the best interests of the City of LeRoy, and that said radio equipment shall be made available for use by LeRoy Emergency Ambulance Service, Inc., and under its auspices through the dispatch service maintained by said organization providing communication services for city and local emergency services providers, and

WHEREAS, the Mayor and City Council of the City of LeRoy have determined that the City of LeRoy can purchase the designated radio equipment at a substantial savings compared to the price at which any other purchaser may be able to acquire said equipment,

NOW, THEREFORE, BE IT ORDAINED by the Mayor and City Council of the City of LeRoy, Illinois, in lawful meeting assembled:

Section 1. That the Mayor and City Clerk of the City of LeRoy are hereby authorized to duly execute the proposed inter-governmental cooperation agreement to be entered into between the City of LeRoy and LeRoy Emergency Ambulance Service, Inc., a copy of which agreement is attached hereto and in which form is approved by the City Council of the City of LeRoy.

That the Mayor and City Clerk shall execute said agreement in Section 2. duplicate retaining one fully executed copy for the City of LeRoy, and that upon the execution of said agreement the Mayor and City Council as well as any other appropriate city officials and employees shall immediately proceed to carry out the terms of said agreement in as prompt and expeditious a manner as possible.

That this ordinance shall be in full force and effect after its passage, approval and publication in pamphlet form as required by law.

THIS AGREEMENT is entered into by and between the CITY OF LeROY, ILLINOIS, an Illinois municipal corporation, and the LeROY EMERGENCY AMBULANCE SERVICE, INC., a not-for-profit corporation organized for the benefit of the public in and about the City of LeRoy, Illinois.

WITNESSETH:

Whereas, the CITY of LeROY, ILLINOIS, is a duly incorporated municipality within the State of Illinois; and

Whereas, the Illinois Constitution of 1970, Article 7, Section 10, provides authority for inter-governmental cooperation between a municipality and a private entity; and

Whereas, the purchase of radio equipment and the provision of dispatching services utilizing said radio equipment, all for the purpose of providing communication services and dispatching services for police, fire and ambulance emergency services within the City of LeRoy, is a common concern and the provision of the best possible services in that regard is a common goal of both the CITY OF LeROY and LeROY EMERGENCY AMBULANCE SERVICE, INC..

NOW, THEREFORE, in consideration of the mutual agreements contained in this agreement, the CITY OF LEROY and LEROY EMERGENCY AMBULANCE SERVICE, INC., agree as follows:

l. In order to provide better communication services for the police, fire and ambulance services, all being emergency services provided by the CITY OF LeROY or which the city assists in providing support for, the purchase of the following piece of equipment, to be used by LeROY EMERGENCY AMBULANCE SERVICE, INC., has been determined to be necessary in order to facilitate efficient communications for the emergency services aforesaid:

Motorola Syntor Radio, Serial #T83SRA 3200-K, and components.

- 2. That for the benefit of the residents and citizens of the City of LeRoy, it has been determined by the parties hereto that the aforesaid radio equipment may be purchased at a substantial reduction in price if it is purchased through the auspices of the CITY OF LeROY.
- 3. The parties hereto agree that the CITY OF LeROY shall purchase the aforesaid radio equipment and shall authorize the installation of same at the emergency services communication station located in the City of LeRoy and operated under the auspices of the LeROY EMERGENCY AMBULANCE SERVICE, INC.
- 4. Leroy EMERGENCY AMBULANCE SERVICE, INC., will use said radio equipment in the dispatch of emergency services personnel within the City of Leroy and for the benefit of the surrounding community.
 - 5. Ownership of the aforesaid radio equipment shall remain in the CITY OF LeROY,

and maintenance of said radio equipment from time to time shall be provided for by one or both of the parties as the parties to this agreement shall agree.

- 6. The CITY OF LeROY may at any time, upon reasonable notice to LeROY EMERGENCY AMBULANCE SERVICE, INC., remove or request the removal of the aforesaid equipment and may then dispose of said equipment as the CITY OF LeROY may deem necessary and appropriate.
- 7. Leroy EMERGENCY AMBULANCE SERVICE, INC., will provide the necessary funds to the CITY OF Leroy in order to enable City to purchase the said equipment. At such time as the use of the said equipment may be terminated by the CITY OF Leroy, or may be otherwise disposed of by the City, with or without the agreement of Leroy EMERGENCY AMBULANCE SERVICE, INC., the CITY OF Leroy shall then pay to Leroy EMERGENCY AMBULANCE SERVICE, INC., that amount of money representing the value of the aforesaid equipment at its then current value based upon competent appraisals or price determined through disposal of said equipment.
- 8. This agreement shall be effective when executed by the Mayor and City Clerk of the CITY OF LeROY, and by the President and Secretary of LeROY EMERGENCY AMBULANCE SERVICE, INC. Unless otherwise terminated, this agreement shall be effective for 15 years.
- 9. This agreement shall be construed in accordance with the law and constitution of the State of Illinois.




