ORDINANCE NO. 615

AN ORDINANCE FOR THE APPROVAL OF A SUBDIVISION AGREEMENT AND BOND

WHEREAS, the Mayor and City Clerk of the City of LeRoy, Illinois, an Illinois municipal corporation, have reviewed a subdivision agreement and bond, and accompanying letter of credit, all submitted by Dr. K. Soundararajan and Bridgett Soundararajan, husband and wife, OWNER/DEVELOPER of the proposed Soundar Addition to the City of LeRoy, and

WHEREAS, the Mayor and City Council deem it to be in the best interests of the City of LeRoy to approve said subdivision agreement and bond to enable the finalization of the proposed final plat of the aforesaid subdivision,

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of LeRoy, in lawful meeting assembled, as follows:

<u>Section 1</u>. That the subdivision agreement and bond and letter of credit, copies of which are attached hereto labeled Exhibit A, and incorporated herein by reference, are hereby approved.

Section 2. The Mayor and City Clerk of the City of LeRoy are hereby directed to sign the aforesaid subdivision agreement, including as many copies as may be appropriate, and the City Clerk is hereby directed to file a complete copy of said subdivision agreement along with the original letter of credit in the permanent records of the City.

<u>Section 3.</u> This ordinance shall be in full force and effect immediately upon its passage and approval, and publication as required by law.

SUBDIVISION AGREEMENT AND BOND

Dr. K. Soundararajan and Bridgett Soundararajan, husband and wife, hereinafter referred to as "OWNER/DEVELOPER," held and firmly bound unto the City of LeRoy, McLean County, Illinois, and Illinois municipal corporation, hereinafter referred to as "CITY" in the penal sum of Seventy four thousand, five hundred ninety-eight and 40/100 dollars (\$74,598.40), lawful money of the United States, for which the undersigned bind themselves as Principal and Surety to be truly made by them, their heirs, executors, administrators, assigns and successors in interest, jointly and severally in the following manner.

SEALED AND DATED this ____17th_ day of July, 1995, at LeRoy, McLean County, Illinois.

WHEREAS, a request has heretofore been filed with the City Council of the City of LeRoy, McLean County, Illinois, for the acceptance of a tract of land as a subdivision to the City of LeRoy, under the name and title of "Soundar Addition," per plat of Perry Lewis, Registered Illinois Land Surveyor Number 1874, consisting of 14 numbered lots and streets, dated June 26, 1995, the plan of which plat has received preliminary approval by the City Council of the City of LeRoy, Illinois, or which preliminary approval has been waived and which plat will be finalized upon OWNER/DEVELOPER's meeting the further requirements of the subdivision ordinance of the City of LeRoy, and

WHEREAS, the legal description of the property sought to be subdivided, for which a final plat will be presented and for which property this bond is given, is as follows, to-wit:

The North 300 feet of the following described real estate:

Part of Lot 17 of the Subdivision of Section 16, Township 22 North, Range 4 East of the Third Principal Meridian, described as follows:

Beginning at the South West corner of Lot 20 of said Subdivision of Section 16, and running thence North 10.06 chains to a point on the North line of Lot 17, 12.65 rods West of the North East corner of said Lot 17, thence West along said North line 4 chains, thence South 10.06 chains to the South line of said Lot 17, thence East 4 chains to the place of beginning.

Lot 16 except the West 9 acres thereof in the Subdivision of Section 16, Township 22 North, Range 4 East of the Third Principal Meridian.

All that part of Lot 17 lying East of the following described tract:

A part of Lot 17 of the Subdivision of Section 16, Township 22 North, Range 4 East of the Third Principal Meridian, described as follows:

Beginning at the South West corner of Lot 20 of said Subdivision of Section 16, and running thence North 10.06 chains to a point of the North line of Lot 17, 12.65 rods West of the North East corner of said Lot 17, thence West along said North line 4 chains, thence South 10.06 chains to the South line of said Lot 17, thence East 4 chains to the point of beginning,

all in the City of LeRoy, County of McLean, State of Ilinois,

and

WHEREAS, OWNER/DEVELOPER, by execution of this agreement and bond, promises and guarantees to pay to CITY the penal sum set forth in this bond and agreement as secured by a Letter of Credit from Busey Bank of McLean County, dated July 17, 1995, and incorporated herein by reference, as a contribution to the cost of constructing said subdivision improvements as more fully detailed in Exhibit A, attached hereto and incorporated herein by reference, upon receipt within two years from the date hereof of a certificate of completion signed by the City Engineer of CITY certifying that the construction of the aforesaid subdivision improvements is not less than the standards set forth by CITY and has been completed.

NOW, THEREFORE, the condition of this obligation is such that if the above bonded OWNER/DEVELOPER shall well and truly keep, do and perform each and every, all and singular, the matters and things set forth and specified in this agreement and bound to be done by OWNER/DEVELOPER and performed by OWNER/DEVELOPER at the time and in the manner as in the obligation and the subdivision ordinance terms of CITY specified, or shall pay over, make good, reimburse and save CITY harmless from all loss and damage which CITY may sustain by reason of failure

or default on the part of said OWNER/DEVELOPER so to do, then this obligation shall be null and void. Otherwise, the same will remain in full force and effect.

IRREVOCABLE LETTER OF CREDIT

The Busey Bank of McLean County, formerly known as LeRoy State Bank

To: County of McLean, Illinois

Date: July 17, 1995

We hereby authorize you to draw from our financial institution up to an aggregate amount of Seventy-four thousand, five hundred ninety-eight and 40/100 United States Dollars (\$74,598.40) (110 percent of estimated construction costs for all subdivision improvements) from the account of Dr. K. Soundararajan and Bridgett Soundararajan, husband and wife, subdivider and/or owner (hereinafter referred to as "Subdivider").

We hereby agree to honor each draft drawn under and in compliance with the terms of this letter, if and when duly presented at this office in LeRoy, Illinois, until the expiration of two (2) years after approval and acceptance by the City of LeRoy, Illinois, of all such subdivision improvements within said subdivision, or until such late date as any written claim by the city against the Subdivider or their financial institution is finally resolved.

The irrevocable credit established by us shall remain in effect without regard to any default in payments of sums owed to us by the Subdivider and without regard to other claims which we may have against the Subdivider. It is recognized that the City of LeRoy is according the Subdivider the permission to proceed with the development of the subdivision expressly upon the guarantee of the irrevocable nature of this

commitment. It is further acknowledged that the consideration for this irrevocable commitment is provided by agreements between this financial institution and the Subdivider.
