ORDINANCE NO. 301

ORDINANCE APPROVING ENGINEERING CONTRACT.

WHEREAS, the City of LeRoy, McLean County, Illinois, an Illinois municipal corporation, is undertaking to advertise for and solicit the submission of bids for repainting all or a portion of the municipal water tower in said City, and

WHEREAS, it is necessary in order to comply with certain regulations of the Farmer's Home Administration of the United States government that the payment for engineering services rendered to the City in connection with said work be properly documented.

NOW. THEREFORE, be it ordained by the Mayor and City Council and the City of LeRoy in lawful meeting assembled as follows:

Section 1. That the engineering contract attached hereto, identified as Exhibit "A," and incorporated herein by reference, is hereby approved.

Section 2. The Mayor and City Clerk of the City of LeRoy are hereby directed to execute said contract, in the original and as many copies as may reasonably be required, retaining a signed copy of the contract for the city, said officers to execute the contract in their official capacities on behalf of the city at such time as they shall deem appropriate and when legally required to do so.

Section 3. This ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as required by law.

AGREEMENT FOR ENGINEERING SERVICES

This agreement made this ______ day of _____, 1987 by and between the City of LeRoy, hereinafter referred to as the OWNER and Perry L. Lewis, dba Lewis Engineering, hereinafter referred to as the ENGINEER.

The OWNER intends to construct a project consisting of the repainting of the existing 250,000 gallon elevated water tower in the City of LeRoy, Illinois. The ENGINEER agrees to perform the various professional engineering services for the design and construction of said project in accordance with the provisions of this agreement.

Section A - Engineering Services

- Engineering Services during the design phase.
 - a. The ENGINEER shall perform the detailed design of the project, prepare contract documents including design drawings, specifications and invitation for bids and prepare a final opinion as to the probable cost of the project.
 - b. The ENGINEER shall assist the OWNER in the Advertisement and Solicitation of bids for this project, attend the bid opening, tabulate the bid proposals, analyze the responsiveness of the bidders and make recommendations for awarding a contract to the lowest responsible, responsive bidder.
- 2. Engineering services during the construction phase.
 - a. Provide general supervision of the project to assure conformance with the plans and specifications, and to provide interpretation of the intent of all contract documents to the Contractor.
 - b. Prepare necessary contract change orders for approval of the OWNER and submission to the Contractor.
 - c. Review all contractor's application for progress and final payments and submit copies of the same to the OWNER with the recommendation for approval or disapproval.

ExhibiT A

Section B - Compensation

- 1. It is hereby mutually agreed by the OWNER and ENGINEER that the ENGINEER shall receive a lump sum \$2,400.00 for all engineering services outlined in Section A-1a and 1b of this agreement. It is further agreed that 90% of this fee shall be due upon the completion of the services outlined in Section A-1a. the remaining 10% of this fee will be due upon the completion of the services outlined in Section A-1b.
- 2. It is further mutually agreed that the ENGINEER shall be paid for the services outlined in Section A-2a, 2b and 2c at an hourly rate of \$39.00 per hour.
