ORDINANCE NO. 456

AN ORDINANCE APPROVING A SETTLEMENT AGREEMENT RESOLVING LITIGATION IN CONNECTION WITH LE ROY AUTO/TRUCK PLAZA ASSOCIATES, LE ROY TRUCK STOP, INC., AND THE COMMUNITY BANK OF GREATER PEORIA, AND THE CITY OF LE ROY

WHEREAS, the City of LeRoy, McLean County, Illinois, an Illinois municipal corporation, is involved in litigation in connection with the LeRoy Auto/Truck Plaza Associates and LeRoy Truck Stop, Inc., truck stop project located in the City of LeRoy; and

WHEREAS, the parties to that litigation have agreed to a settlement of the various cases and countersuits involved, all said cases being designated under the McLean County Circuit Court Case No. 89-CH-13, insofar as the City of LeRoy is connected with such litigation; and

WHEREAS, the Mayor and City Council of the City of LeRoy, have reviewed the aforesaid settlement agreement in its entirety, are familiar with the provisions set forth therein, and have determined that it is in the best interests of the City of LeRoy to enter into said settlement agreement resolving all litigation as aforesaid,

NOW, THEREFORE, BE IT ORDAINED, by the City Council of the City of LeRoy, McLean County, Illinois, in lawful meeting assembled, as follows:

SECTION 1. The settlement agreement as previously submitted to the Mayor and City Council of the City of LeRoy, prior to the regular meeting held at 7:30 p.m. on August 17, 1992, has been reviewed in its entirety by the Mayor and each member of the City Council, and the City Council hereby finds that each member is familiar with the provisions of said agreement and finds that entering into said agreement is in the best interests of the City and the residents of said City.

SECTION 2. That agreement in the form as previously submitted to the Mayor and City Council under cover of a letter dated August 10, 1992, from Frank Miles, special counsel for the City of LeRoy, herein incorporated by reference, is hereby approved and the Mayor and City Clerk of the City of LeRoy are hereby authorized to sign said settlement agreement, in the original and as many copies as may reasonably be required, and to sign any other related documents necessary to implement said agreement, and to return said settlement agreement and any related documents to the

special counsel for the City of LeRoy to assist in completing said settlement agreement and the matters related thereto in order to make the same binding on all parties to the aforesaid litigation.
