### ORDINANCE NO. 486

# AN ORDINANCE APPROVING A SETTLEMENT AGREEMENT WITH THE TRUSTEE IN THE BANKRUPTCY OF THE BANKRUPTCY OF LAWRENCE E. MARSH REGARDING FULFILLMENT OF TERMS OF A PRE-ANNEXATION AGREEMENT BETWEEN THE CITY OF LE ROY AND LAWRENCE E. MARSH

WHEREAS, the City of LeRoy entered into an annexation agreement dated October 3, 1977, with Lawrence E. Marsh, the subject of which pre-annexation agreement was the proposed annexation of Golden Eagle Estates Subdivision to the City of LeRoy; and

WHEREAS, subsequent to the date of said agreement, and subsequent to the date of the annexation of the aforesaid subdivision to the City of LeRoy, McLean County, Illinois, Lawrence E. Marsh filed a petition in bankruptcy with the U.S. Bankruptcy Court for the Central District of Illinois; and

WHEREAS, said bankruptcy case is still active; and

WHEREAS, the City of LeRoy, in accordance with the aforesaid pre-annexation agreement, had a continuing obligation to Lawrence E. Marsh, and his successors in interest to his interest in the aforesaid agreement, whereby the City of LeRoy was to pay \$100.00 to Lawrence E. Marsh or his successors in interest for each water main service established in Golden Eagle Estates Subdivision; and

WHEREAS, the Trustee in bankruptcy in regard to the bankruptcy of Lawrence E. Marsh has proposed a final settlement of the obligation of the City of LeRoy under the aforesaid pre-annexation agreement, and the Mayor and City Council of the City of LeRoy, McLean County, Illinois, an Illinois municipal corporation, after due consideration, have determined that the settlement proposed by the trustee in bankruptcy is in the best interests of the City and its residents,

NOW. THEREFORE. BE IT ORDAINED, by the City Council of the City of LeRoy, Illinois, in lawful meeting assembled, as follows:

SECTION 1. The proposed settlement agreement set forth in Exhibit "A," attached hereto and incorporated herein by reference, is accepted effective the date of passage of this ordinance, and the settlement agreement, set forth in Exhibit "A," attached hereto and incorporated herein by reference, is hereby approved.

SECTION 2. The Mayor and City Clerk of the City of LeRoy are hereby directed to execute the settlement contract, attached hereto as Exhibit "A," in the original and as many copies as may reasonably be required, retaining a signed copy of the settlement agreement for the City, after it has been executed by all parties.

**SECTION 3.** This ordinance shall be in full force and effect from and after its passage, approval, and publication in pamphlet form as required by law.

WHEREAS, the City has an agreement with Lawrence Marsh to reimburse Lawrence Marsh for watermain extensions at a rate of \$100.00 for each new house built in Golden Eagle Estates, and

WHEREAS, at the present time there are 40 vacant lots in Golden Eagle Estates in connection with which the City of LeRoy has an obligation to reimburse Lawrence Marsh at such time that new homes are built on such vacant lots, and

WHEREAS, the Trustee has succeeded to the rights of Lawrence Marsh to receive the payments described herein, and

WHEREAS, it is not possible to accurately predict how quickly houses will be built on the remaining 40 vacant lots,

NOW, THEREFORE, it is agreed as follows:

- 1. The City of LeRoy shall pay to the Trustee, in a single lump sum payment, the sum of \$1,000.00 in complete satisfaction of the entire obligation of the City of LeRoy to make payments to Lawrence Marsh for watermain extensions in Golden Eagle Estates.
- 2. Upon receipt of such \$1,000.00 payment, Trustee agrees to release the City of LeRoy from all further obligation under the City's Agreement with Lawrence Marsh.

- 3. This Agreement shall be subject to the approval of the Bankruptcy Court in the Bankruptcy of Lawrence Marsh, Case No. 87-70161.
- 4. The City agrees to make payment to the Trustee of the \$1,000.00 described in Paragraph 1 herein within 14 days after the Bankruptcy Court Order approving this Agreement becomes final.
- 5. This Agreement shall be binding upon and inure to the benefit of the parties hereto and their respective successors in interest.
