### AN ORDINANCE APPROVING A CONTRACT WITH ROWE CONSTRUCTION, INC., A DIVISION OF R.A. CULLINAN & SON, Inc. FOR THE HEMLOCK STREET RECONSTRUCTION

WHEREAS, the Mayor and City Council of the City of LeRoy, McLean County, Illinois, an Illinois municipal corporation, have reviewed the contract for the Hemlock Street Reconstruction project, incorporated herein and attached hereto as Exhibit "A," and have determined that approval of the same by the City of LeRoy is in the best interests of the City and its residents;

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of LeRoy, Illinois, in lawful meeting assembled, as follows:
