## AN ORDINANCE PROHIBITING THE CONNECTION OF SANITARY OR WASTE SEWERS TO STORM DRAINAGE SYSTEMS IN THE CITY OF LEROY, MCLEAN COUNTY, ILLINOIS

BE IT ORDAINED, by the City Council of the City of LeRoy, McLean County, Illinois, in lawful meeting assembled as follows:

Section 1. It shall be unlawful for any person, firm, corporation or institution, public or private, to connect, or cause to be connected, any drain carrying, or to carry, any toilet, sink, basement, septic tank, cesspool, industrial waste, or any fixture or device discharging polluting substances to any open ditch, drain, or drainage structure installed solely for street or highway drainage purposes in the City of LeRoy, McLean County, Illinois.

- <u>Section 2.</u> This ordinance is intended to and shall be in addition to all other ordinances, state statutes, rules and regulations concerning pollution and shall not be construed as repealing or rescinding any other ordinance or part of any ordinance unless in direct conflict therewith.
- Section 3. Any person, firm, or corporation violating this ordinance shall be fined not less than \$50.00 nor more than \$500.00 for each offense, and a separate offense shall be deemed committed for each and every day during which a violation continues or exists.
- Section 4. This ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as required by law.
