AN ORDINANCE AMENDING THE MUNICIPAL CODE, LEROY, ILLINOIS, 1975, CHAPTER 34, LIQUOR, SECTION 34.19(b) and (c).

BE IT ORDAINED by the Mayor and City Council of the City of LeRoy, Illinois:

Section 1. That Chapter 34, Section 34.19(b) is hereby amended to read as follows:

"No licensee nor any officer, associate, member, representative, agent or employee of such licensee shall sell, give or de-Tiver alcoholic liquor to any person under the age of twenty-one years, or to any intoxicated person, or to any person known to be a habitual drunkard, spendthrift, insane, mentally ill, mentally deficient or in need of mental treatment. No person after purchasing or otherwise obtaining alcoholic liquor shall sell, give or deliver such alcoholic liquor to another person under the age of twenty-one years except in the performance of a bonafide religious ceremony or service."

Section 2. That Chapter 34, Section 34.19(c) is hereby repealed.

Section 3. That this Ordinance shall be in full force and effect after its passage and approval and publication as required by law.
