ORDINANCE NO. 384

AN ORDINANCE AMENDING CHAPTER 34, THE MUNICIPAL CODE, LE ROY, ILLINOIS, 1975 (AS AMENDED)

WHEREAS, the City Council of the City of LeRoy, McLean County, Illinois, an Illinois municipal corporation, hereinafter referred to as "CITY," has determined that it is in the best interests of the City and its residents to amend the ordinances regarding regulation of the sales of liquor within said CITY,

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of LeRoy, in lawful meeting assembled, as follows:

Section 1. Chapter 34 is hereby amended by the addition of the following new section in words as follows:

Section 34.05 A. Before a liquor license shall be granted to a corporation, the corporation shall file with the Liquor Control Commissioner the name of the manager of the premises for which the license is applied for, or the name of any other agent who shall be involved with the business operated at the premises for which (premises and business) the liquor license is granted. The aforesaid manager or other agent shall have authority to bind the corporation in regard to matters between the CITY and the liquor license holder that may arise in connection with the CITY's ordinances and the liquor license. Said manager or other agent shall be a resident of the CITY. The Liquor Commissioner of the City of LeRoy shall determine if a background check in regard to the manager or other agent shall be required. Said person may be exempted from meeting the qualifications requirements of the license applicant if the Liquor Commissioner determines that requiring said individual to meet the qualifications is not necessary.

Section 2. This ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as required by law.
