ORDINANCE NO. 547

AN ORDINANCE AMENDING CHAPTER 34, LIQUOR, OF THE MUNICIPAL CODE OF LEROY, ILLINOIS, 1975 (as amended)

WHEREAS, the Municipal Code of the City of LeRoy, Illinois, 1975 (as amended), Chapter 34, LIQUOR, does not expressly prohibit or allow alcoholic beverages to be served in outdoor areas located upon licensed premises, and

WHEREAS, the Mayor and City Council of the City of LeRoy, Illinois, an Illinois municipal corporation, have determined that it is in the best interests of the City and its residents that the outdoor sale and serving of alcoholic beverages be generally prohibited,

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of LeRoy, in lawful meeting assembled, as follows:

Section 1. Chapter 34, LIQUOR, Municipal Code of LeRoy, Illinois, 1975 (as amended), is hereby amended by addition of new Section 34.21 A in words as follows:

Section 34.21 A SALES AND CONSUMPTION LIMITED TO INDOORS AREAS.

Premises upon which the sale of alcoholic liquor for consumption on or off the premises is licensed are required to keep the sales areas and areas in which consumption is permitted entirely enclosed by walls, roof, doors and windows (with windows and doorways all meeting the requirements of Section 34.21 of this chapter). All enclosed areas used for sales or serving must be reasonably capable of being heated or cooled, as the weather may dictate, the same as any other enclosed portion of the premises. No sales or consumption of alcoholic beverages shall be permitted in any open area, whether fenced or walled, or otherwise, such as a "beer garden," patio area, deck, or other similar open or open-air area normally used only during certain seasons of the year, and when weather permits.

<u>Section 2.</u> This ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form, as required by law.
