If you do not agree with these figures, please telephone Tisha McKinney at (309) 888-5187, e-mail <u>tisha.mckinney@mcleancountyil.gov</u> or fax (309) 888-5932 **immediately** with your proposed changes.

Note: According to the Truth in Taxation Act, if your aggregate levy is more than 105% of last year's aggregate extension, and you did not publish a notice, hold a hearing, and file a compliance certificate, the County Clerk must reduce the amount of the current aggregate extension to an amount which does not exceed 105% of the previous year's aggregate extension. Aggregate levy and extension does not include bond or public building commission lease funds.

Given the very difficult economic climate that we are encountering and the economic uncertainty that we face in the coming months, I would encourage you to strive to **complete this verification and acceptance process on or before February 28th**. The sooner we receive signed Tax Computation Reports from all taxing districts, the sooner we will be able to complete our tax extension process. Tax bills will then be mailed, collected, and funds will be distributed to you.
