ORDINANCE NO.	672

AN ORDINANCE AMENDING CHAPTER 42, SECTION 42.13 (b), OF THE MUNICIPAL CODE OF LEROY, ILLINOIS, 1975 (AS AMENDED)

WHEREAS, the Mayor and City Council of the city of LeRoy, McLean County, Illinois, an Illinois municipal corporation, have determined that it may be appropriate to permit young people within the community to be out at a later hour than has previously been permitted for those persons under the age of 17 years old,

NOW, THEREFORE, BE IT ORDAINED, by the City Council of the City of LeRoy, Illinois, in lawful meeting assembled, as follows:

Section 1. That Chapter 42, Section 42.13 (b), Municipal Code of the City of LeRoy, Illinois, 1975 (as amended), is hereby amended by substituting the numbers and letters "11:00 P.M." for the numbers and letters "10:00 P.M." where the latter appear in the last line Section 42.13 (b), as the same was worded in Section 2 of Ordinance No. 129, passed and approved on December 15, 1980.

<u>Section 2</u>. In all other respects Section 42.13, and all of its respective subsections, of Chapter 42, Municipal Code of the City of LeRoy, Illinois, 1975 (as amended), shall continue in full force and effect.

<u>Section 3</u>. This ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as required by law.
