

AN ORDINANCE AMENDING THE MUNICIPAL CODE, LE ROY, ILLINOIS 1975, CHAPTER 13, DOGS AND OTHER ANIMALS, SECTIONS 13.01 - 13.05, inclusive.

BE IT ORDAINED by the Mayor and City Council of the City of LeRoy, Illinois:

Section 1. That Chapter 13, Sections 13.01 - 13.05 of the Municipal Code, LeRoy, Illinois, 1975, as amended, are hereby amended by addition of Section 13.05 1/2 which shall read as follows:

"Wherever the words "dog" or "dogs" shall appear in Sections 13.01 - 13.05, inclusive, preceding this section, said words shall be taken and read to include the words "and cat" or "and cats", in either the singular or plural as shall be required for purposes of proper grammatical usage, after the words "dog" or "dogs", and said sections shall apply to cats as well as to dogs."

Section 2. That this ordinance shall be in full force and effect after its passage, approval and publication, as required by law.
