AN ORDINANCE AMENDING THE MUNICIPAL CODE, LEROY, ILLINOIS, 1975, CHAPTER 2, CITY COUNCIL, SECTION 2.05.

BE IT ORDAINED by the Mayor and City Council of the City of LeRoy, Illinois, as follows:

Section 1. That Chapter 2, Section 2.05, of the Municipal Code, LeRoy, Illinois, 1975, as amended, is hereby further amended by the addition of the following language at the end of the present Section to read as follows:

"Newly elected officers shall take office at the first regular or special meeting held in the first month succeeding the month in which the election for office is held, beginning with the election to be held in April, 1981."

Section 2. This Ordinance shall be in full force and effect after its passage, approval, and publication in form as required by law and approved by the City Council.
