ORDINANCE NO. 245

AN ORDINANCE AMENDING CHAPTER 3, CITY ADMINISTRATION, SECTION 3.05(g), MUNICIPAL CODE OF LEROY, 1975 (AS AMENDED).

WHEREAS, The City of LeRoy, McLean County, Illinois, did adopt Ordinance No. 242 on May 6, 1985, being an ordinance providing for amendment, as set forth therein, of Chapter 3, City Administration, Municipal Code of LeRoy, Illinois 1975 (as amended), by addition of new sub-section 3.05(g); and

WHEREAS, The numbering sequence of said section was incorrectly numbered 3.05 but should have been numbered 3.04 as to said sub-section (g),

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of LeRoy, Illinois, in lawful meeting assembled as follows:

Section 1. That Ordinance No. 242 is hereby amended to read "3.04" in place of "3.05" and as to all references set forth in said ordinance to the section numbered "3.05".

Section 2. That this ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as required by law.
