

AN ORDINANCE ESTABLISHING THE OFFICE OF  
ASSISTANT SUPERINTENDENT OF STREETS, AND AMENDING CHAPTER 3,  
CITY ADMINISTRATION, SECTION 3.01(e), MUNICIPAL CODE  
OF LE ROY, ILLINOIS 1975 (AS AMENDED)

WHEREAS, the City Council of the City of LeRoy, McLean County, Illinois, an Illinois municipal corporation, has determined that the duties of the Superintendent of Streets of the City of LeRoy require that an assistant be made available from time to time; and, further, the City Council of the City of LeRoy, McLean County, Illinois, an Illinois municipal corporation, has determined that the duties of the Superintendent of Water Works require that two assistants be made available from time to time, one assistant being an assistant for the Water Works, and another being an assistant for the Sewer Plant; and

WHEREAS, the City Council has determined that it is desirable from time to time to have a subordinate officer to be responsible for fulfilling the duties necessary for each of the aforesaid assistant capacities, and to be available to fill in on a temporary basis from time to time for the Superintendent of Streets, or for the Superintendent of Water Works,

NOW, THEREFORE, BE IT ORDAINED, by the City Council of the City of LeRoy, Illinois, in lawful meeting assembled, as follows:

Section 1. Chapter 3, City Administration, Section 3.01 MAYOR., of the Municipal Code of LeRoy, Illinois 1975 (as amended), sub-section (e), is hereby repealed.

Section 2. New sub-section (e) of Chapter 3, City Administration, Section 3.01 MAYOR., of the Municipal Code of LeRoy, Illinois 1975 (as amended), is hereby added in words and figures as follows:

(e) Appointment of City Officers; Filling Vacancies. The Mayor shall appoint, by and with the advice and consent of the City Council, a City Attorney, Marshal/Police Chief, Assistant Marshal/Assistant Police Chief, Superintendent of the Street Department, Assistant Superintendent of the Street Department, Superintendent of the Water Department (who shall also be superintendent of the Sewer Plant), Assistant Superintendent of the Water Department - Water Works, and Assistant Superintendent of the Water Department - Sewer Plant, and all officers of the city whose

appointment is not otherwise provided for by law, and whenever a vacancy shall occur in any office which by law or ordinance he or she is empowered and required to fill, he or she shall, at the next regular meeting of the City Council, communicate to the City Council the name of his or her appointee to such office, and pending the concurrence of the City Council in such appointment, he or she may designate some suitable person to discharge the functions of such office.

Section 3. This ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as required by law.






