AN ORDINANCE AMENDING ORDINANCE NO. 179, POLICIES, RULES AND REGULATIONS FOR CITY OFFICERS AND EMPLOYEES OF THE CITY OF LE ROY, ILLINOIS.

Whereas, the Mayor and City Council of the City of LeRoy, McLean, County, Ill, an Illinois municipal corporation, have determined that it is in the best interests of the City of LeRoy to extend further benefits to its employees; and

Whereas, the Mayor and City Council of the City of LeRoy have been informed that the group health insurance rates for the employees of the City, both as to the individual health insurance premium and as to the family health insurance premium, are to be increased effective December 15, 1983,

NOW, THEREFORE, BE IT ORDAINED by the Mayor and City Council of the City of LeRoy, Illinois, in lawful meeting assembled:

Section 1. That Section II E, of Ordinance No. 179, Policies, Rules and Regulations for City Officers and Employees, adopted April 18, 1983, is hereby repealed.

Section 2. That new Section II E, is hereby adopted in words and numbers as follows:

"E. The City of LeRoy will pay on all full-time employees health insurance with dental clause for both single person coverage and for family coverage if requested by the employee for the health insurance program provided by the City to its employees as a group benefit."

Section 3. That this ordinance shall be in full force and effect after its passage, approval and publication in pamphlet form as required by law.
