ORDINANCE NO. 480

**AN ORDINANCE AMENDING ORDINANCE 458 - SALARY SCHEDULE
ORDINANCE OF THE CITY OF LeROY
EFFECTIVE MAY 1, 1992**

WHEREAS, the Mayor and City Council of the City of LeRoy, McLean County, Illinois, an Illinois municipal corporation, have determined that it is appropriate to amend Ordinance No. 458, Salary Schedule Ordinance of the City of LeRoy, effective May 1, 1992, and

WHEREAS, the Mayor and City Council of the City of LeRoy find that due to changes and reductions in the insurance premium required for health insurance coverage for certain officers and employees of the City of LeRoy that the City will benefit by not being required to expend as substantial an amount of funds for the aforesaid insurance premiums as had been expected on or before May 1, 1992, for the fiscal year beginning May 1, 1992, and ending April 30, 1993, and the Mayor and City Council further find that it is appropriate to pass the savings in insurance premiums on to designated city officers and employees as set forth hereafter, and

WHEREAS, in order to pass the benefit realized by the City to the designated city officers and employees it is necessary and appropriate to adjust the salary and pay rates designated for certain officers and employees of the City,

NOW, THEREFORE, BE IT ORDAINED, by the City Council of the City of LeRoy, in lawful meeting assembled, as follows:

Section 1. SECTION II. Salary and Pay Schedule for Appointed Officers and Employees, of Ordinance 458 is hereby amended as follows:

- (a). The third line under said section, "Superintendent of Street Department," which now designates \$22,798.00 per year for such employees

is hereby increased to "\$24,358.00" per year and the appropriate deletion of "\$22,798.00" and substitution of "\$24,358.00" is hereby made;

(b). The fifth line under said section, "Street Department Employees (Full-time)," which now designates \$8.57 per hour for such employees is hereby increased to "\$9.32" per hour and the appropriate deletion of "\$8.57" and substitution of "\$9.32" is hereby made;

(c). The ninth line under said section, "Police Officers (Full-time, with PTI)," which now designates \$9.25 per hour for such employees is hereby increased to "\$10.00" per hour and the appropriate deletion of "\$9.25" and substitution of "\$10.00" is hereby made;

(d). The tenth line under said section, "Police Officers (Full-time, no PTI)," which now designates \$8.00 per hour for such employees is hereby increased to "\$8.75" per hour and the appropriate deletion of "\$8.00" and substitution of "\$8.75" is hereby made;

(e). The fifteenth line under said section, "Water Plant Supervisor," which now designates \$10.00 per hour for such employees is hereby increased to "\$10.75" per hour and the appropriate deletion of "\$10.00" and substitution of "\$10.75" is hereby made;

(f). The twenty-third line under said section, "Sewer Treatment Plant Supervisor," which now designates \$10.00 per hour for such employees is hereby increased to "\$10.75" per hour and the appropriate deletion of "\$10.00" and substitution of "\$10.75" is hereby made;

(g). The thirty-second line under said section, "Director of Public Works," which now designates \$30,000.00 per year for such employees is hereby

increased to "\$31,560.00" per year and the appropriate deletion of "\$30,000.00" and substitution of "\$31,560.00" is hereby made;

(h). The thirty-fifth line under said section, "City Clerk's Administrative Assistant," which now designates \$7.57 per hour for such employees is hereby increased to "\$8.32" per hour and the appropriate deletion of "\$7.57" and substitution of "\$8.32" is hereby made;

SECTION 2. The aforesaid adjustments and amendments to Ordinance No. 458, Salary Schedule Ordinance of the City of LeRoy, is hereby made effective retroactive to and including December 1, 1992. All additional pay less any appropriate withholding amounts shall be adjusted for the period beginning December 1, 1992, and including through the date of the pay period ending next after the date of adoption of this ordinance, and such adjustment shall be paid in a lump-sum on the next employee's paycheck being due after the close of said pay period.

SECTION 3. This Ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as required by law.


