

AN ORDINANCE AMENDING ORDINANCE 458 - SALARY SCHEDULE
ORDINANCE OF THE CITY OF LE ROY
EFFECTIVE MAY 1, 1992

WHEREAS, the Mayor and City Council of the City of Le Roy, McLean County, Illinois, an Illinois municipal corporation, have determined it is appropriate to amend Ordinance No. 458, Salary Schedule Ordinance of the City of Le Roy, effective May 1, 1992 as follows:

"Any employee assigned to acting position of Supervisor or higher position shall be paid \$12.00 per hour after a period of (72) seventy two hours then to be paid that rate from start date with exception of Acting City Marshal/Police Chief who shall receive an hourly rate equal to City Marshal/Police Chief salary from starting date"

BE IT FURTHER ORDAINED that all prior ordinances or portions thereof of this City in conflict herewith be and they are hereby repealed.


