ORDINANCE 08-03-01-70

AN ORDINANCE AMENDING TITLE SIX MOTOR VEHICLES AND TRAFFIC, CHAPTER TWO TRAFFIC REGULATIONS, SECTION THREE, SPEED REGULATIONS, MUNICIPAL CODE OF LE ROY, ILLINOIS, 2003 (as amended)

Whereas, the Mayor and City Council of the City of Le Roy, McLean County, Illinois, an Illinois municipal corporation, have determined that it is in the best interests of the residents of the City of Le Roy that Title Six, Motor Vehicles and Traffic, Chapter Two, Traffic Regulations, Section Three, Speed Regulations, Municipal Code of Le Roy, Illinois, 2003 (as amended), be amended to provide for certain regulation of the speed of motor vehicular traffic within the city limits, and to provide for the appropriate regulation of the speed limit,

NOW, THEREFORE, BE IT ORDAINED, by the City Council of the City of Le Roy, McLean County, Illinois, in lawful meeting assembled, as follows:

Section 1. Chapter Two, Traffic Regulations, of the Municipal Code of Le Roy, Illinois, 2003 (as amended), is hereby amended by deleting Title Six, Motor Vehicles and Traffic, Chapter Two, Traffic Regulations, Section Three, Speed Regulations, (6-2-3 B).

B. Speed Limits On Certain Streets; Vehicle Operation: On the basis of an engineering or traffic investigation conducted by the city, it has been determined that on various portions of city streets the speed permitted by state law is greater or lesser than is reasonable or safe under the conditions found to exist on such streets. The maximum speed limits on such streets or parts of streets are as determined by the city, which speeds declared shall be effective when signs are erected giving notice thereof. It shall be illegal for any person to drive a motor vehicle in excess of the speed therein stated. (Ord. 558, 9-19-1994)

Section 2. Chapter Two, Traffic Regulations, of the Municipal Code of Le Roy, Illinois, 2003 (as amended), is hereby amended by addition of new Title Six, Motor Vehicles and Traffic, Chapter Two, Traffic Regulations, Section Three, Speed Regulations, (6-2-3B) in word and figures as follows:

B. Speed Limits On Certain Streets; Vehicle Operation: On the basis of an engineering or traffic investigation conducted by the city, it has been determined that on various portions of city streets the speed permitted by state law is greater or lesser than is reasonable or safe under the conditions found to exist on such streets. The maximum speed limits on such streets or parts of streets are as determined by the city, which speeds declared shall be effective when signs are erected giving notice thereof. It

shall be illegal for any person to drive a motor vehicle in excess of the speed therein stated.

SCHEDULE C: 20 Miles Per Hour

In accordance with Title Six, Chapter Two, Section Three (B) - of this chapter, all vehicles traveling on the following named streets or portions there of shall not exceed the speed limit as set forth hereinafter for such street or streets, or any portion thereof;

- a. East and West Bound on Warren Street between East and Pearl Streets.
- b. East and West bound on Washington Street between East and Pearl Streets.
- c. North and South bound on Pearl Street between Washington and Warren Streets.
- d. North and South bound on Pearl Street between Cherry and Center Streets.
- e. North and South bound on East Street between Washington and Warren Streets.
- f. East and West bound on Cherry Street between Pearl and Mill Streets.
- g. South bound on Mill Street between Cherry and Center Streets.
- h. East and West bound on Washington Street between Lynn Street and the beginning of the first curve east of Lynn Street on Washington Street.
- i. East and West bound on Meadow Lane between Barnett Street and the City limits.
- j. North and South bound on East Street between Cedar and Sunset Drive
- k. East and West bound on Center Street between Walnut Street and Park Ave
- l. North and South bound on Park Ave between Center Street and Vine Streets.

SCHEDULE D: 20 Miles Per Hour

In accordance with Title Six, Chapter Two, Section Three (B), of this chapter, all vehicles traveling on the following named streets or portions thereof shall not exceed a maximum speed of twenty (20) miles per hour on said street or streets, or portion thereof designated as a school speed zone, said speed zone being in force on school days when children are present:

- a. Mill Street between Center Street and Pine Street
- b. Pine Street between Mill Street and Park Street
- c. Center Street between Mill Street and Lynn Street
- d. Lynn Street between Center Street and Pine Street
- e. Barnett Street between Meadow Lane Street to Wayne Street
