BE IT ENACTED by the CITY COUNCIL, CITY OF LeROY, at a regular meeting held on January 16, 1978 that the following traffic regulations, stop signs, speed zones and location of traffic signs are hereby established for the CITY OF LeROY, in addition to any other existing Ordinances dealing with the same subject:

I. A School speed zone of 20 miles per hour is hereby established on the following Streets in the City of LeRoy at the places described:

## BARNETT STREET -- NORTH BOUND TRAFFIC

- 1. east side of Barnett between Warren and Green
- 2. east side of Barnett North of Washington Street
- 3. Pine and Center Streets between Pearl and East

# MILL STREET -- SOUTH BOUND TRAFFIC

- 1. between Washington and Wayne
- between Green and Wayne
- Pine and Center between Pearl and Mill
- 4. Pine Street between Daniel and Lynn Streets

## SPEED LIMIT

WASHINGTON STREET -- 20 MPH between Lynn Street and first curve east going into subdivision

SCHOOL STREET --

- 30 MPH north side of street for westbound traffic between Main and Walnut
- 30 MPH north side of street for westbound traffic between East and Chestnut

WEST STREET --

- 30 MPH east side of street for northbound traffic between School and Supreme Court Drive
- 30 MPH east side of street for northbound traffic between Green and Wayne Streets

## 20 MPH SIGNS

REMOVE ALL OLD SIGNS THAT ARE NOW UP AND NO LONGER NEEDED; REPLACE THOSE THAT ARE LEGAL AND ARE UNREADABLE AND RUSTED.

CONTACT STATE HIGHWAY DEPARTMENT AND SEE IF A SIGN CAN BE PUT UP JUST EAST OF PARK AVENUE FOR EASTBOUND TRAFFIC TO BE AWARE OF ANOTHER STREET INTERSECTION (GILMORE AVE.).

II. Violation of any of the above regulations by any person shall be a violation of law and shall subject such violator to the penalties described in the City Code for the City of LeRoy, Illinois in Chapter 4/\_.
