ORDINANCE NO. 594

AN ORDINANCE AMENDING CHAPTER 41 TRAFFIC, MUNICIPAL CODE OF LEROY, ILLINOIS, 1975 (as amended), BY AMENDMENT OF SECTION 41.30 - SPEED REGULATIONS

WHEREAS, the Mayor and City Council of the City of LeRoy, McLean County, Illinois, an Illinois municipal corporation, have determined that it is in the best interest on the residents of the City of LeRoy that Chapter 41, TRAFFIC of the Municipal Code of the City of LeRoy, Illinois, 1975 (as amended), Section 41.30, be amended by addition of one or more speed zones, said additions to also be noted in an amended Schedule C to Chapter 41,

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of LeRoy, McLean County, Illinois, in lawful meeting assembled follows:

Section 1. Section 41.30, Chapter 41, TRAFFIC, of the Municipal Code of LeRoy, Illinois, 1975 (as amended), is hereby amended by addition of speed zones set forth as follows:

2. Twenty-five (25) miles per hour

Section 2. Schedule C attached to Chapter 41, TRAFFIC, of the Municipal Code of LeRoy, Illinois, 1975 (as amended), is hereby amended as set forth in the attached Exhibit I, being Schedule C as amended by this ordinance.

<u>Section 3</u>. This ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form, as required by law

SCHEDULE C

In accordance with Section 1 (c) - Chapter 41.30. Traffic, of this chapter, all vehicles traveling on the following named streets or portions thereof shall not exceed the speed limit as set forth hereinafter for such street or streets, or any portion thereof:

1. Twenty (20) miles per hour

- (a) East and west bound on Warren Street between East Street and Pearl Street.
- (b) East and west bound on Washington Street between East Street and Pearl Street.
- (c) North and south bound on Pearl Street between Washington Street and Warren Street.
- (d) North and south bound on Pearl Street between Cherry Street and Center Street.
- (e) North and south bound on East Street between North Street and Warren Street.
- (f) East and west bound on Cherry Street between Pearl Street and Mill Street.
- (g) East and west bound on Center Street between the Circle and Mill Street.
- (h) South bound on Mill Street between Cherry Street and Center Street.
- (i) East and west bound on Washington Street between Lynn Street and the beginning of the first curve east of Lynn Street on Washington Street.
- (j) Meadow Lane.

2. Twenty-five (25) miles per hour

(a) All streets in Golden Eagle Subdivision, including:

Cardinal Court

Dove Avenue

Blue Jay Drive

Mockingbird Lane

Pheasant Lane

Oriole Drive
