ORDINANCE NO. _ 794

AN ORDINANCE AMENDING SECTION 41.30-SPEED REGULATIONS, OF CHAPTER 41, TRAFFIC, MUNICIPAL CODE OF THE CITY OF LE ROY, ILLINOIS, 1975 (AS AMENDED)

WHEREAS, the Mayor and City Council of the City of LeRoy, McLean County, Illinois, an Illinois municipal corporation, have determined that it is in the best interest of the residents of the City of LeRoy that Section 41.30 - Speed Regulations, of Chapter 41, TRAFFIC, Municipal Code of the City of LeRoy, Illinois, 1975 (as amended), be amended to provide for the certain regulation of the speed of motor vehicle traffic upon South East Street in the City of LeRoy, Illinois,

NOW, THEREFORE, BE IT ORDAINED, by the City Council of the City of LeRoy, McLean County, Illinois, in lawful meeting assembled, as follows:

Section 1. Section 41.30-Speed Regulations, of Chapter 41, TRAFFIC, of the Municipal Code of the City of LeRoy, Illinois, 1975 (as amended), is hereby amended in words and figures as follows:

Schedule C of Chapter 41, TRAFFIC, of the Municipal Code of the City of LeRoy, Illinois, 1975 (as amended) is hereby amended by addition of a designated portion of East Street, being South East Street from the south right-of-way line of Cedar Street to the westerly extension of the North right-of-way line of Maple Street, where Maple Street intersects with South East Street, which is hereby designated to have a maximum speed limit of 20 miles per hour, which speed limit shall be effective when signs are erected giving notice thereof. It shall be illegal for any person to drive a motor vehicle in excess of the aforesaid speed on said portion of South East Street. Schedule C is hereby amended as set forth in attached Exhibit I, being a copy of Schedule C showing the amending language in bold print.

<u>Section 2</u>. This ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form, as required by law.

- (c) North and south bound on Pearl Street between Washington Street and Warren Street.
- (d) North and south bound on Pearl Street between Cherry Street and Center Street.
- (e) North and south bound on East Street between North Street and Warren Street.
- (f) East and west bound on Cherry Street between Pearl Street and Mill Street.
- (g) East and west bound on Center Street between the Circle and Mill Street.
- (h) South bound on Mill Street between Cherry Street and Center Street.
- (i) East and west bound on Washington Street between Lynn Street and the beginning of the first curve east of Lynn Street on Washington Street.
- (j) Meadow Lane.
- (k) From the East side of Barnett Street at the intersection of East Washington Street to the east side of the intersection of North Lynn Street and East Washington Street.
- (i) North and South bound on South East Street between Cedar Street and Maple Street.
