ORDINANCE NO. 16-09-02-70

**AN ORDINANCE AMENDING SECTION 1-4-3B
OF THE LE ROY CITY CODE – OPEN FIRES**

WHEREAS, the City of Le Roy is an Illinois municipality with authority to enact ordinances for the promotion of the health, safety and welfare of the citizens of Le Roy; and

WHEREAS, Le Roy prohibits burning within the corporate limits, except under certain circumstances, as provided in Section 4-4-2 of the City code; and

WHEREAS, Section 1-4-3B of the Le Roy City Code provides for the settlement of certain Ordinance violation charges at City Hall; and

WHEREAS, the Mayor and Council for the City of Le Roy find it in the best interest of the health, safety and welfare of the citizens of Le Roy to increase the settlement amounts at City Hall for open fires as provided herein;

NOW, THEREFORE, BE IT ORDAINED by the Mayor and City Council of the City of Le Roy, McLean County, Illinois, as follows:

Section 1. That Section 1-4-3B Resolving Citation Charges, Offense #6 Open Fires, be and the same is hereby amended by deleting the current settlement amounts of \$50, \$100 and \$150 for the first, second, third and subsequent offenses, respectively and inserting, in lieu thereof, new settlement amounts for violation of Code 4-4-2 Open Fires in the following amounts: First Offense \$250; Second Offense \$500; Third and subsequent offenses \$750.

Section 2. That the City Code for the City of Le Roy shall continue in full force and effect as amended by this Ordinance.

Section 3. All Ordinances and parts of Ordinances in conflict with this Ordinance are hereby repealed, provided, however, that nothing herein contained shall affect any rights, action or causes of action, which shall have accrued to the City of Le Roy, prior to the effective date of this Ordinance.

Section 4. The City Clerk be and she is hereby authorized and directed to publish this Ordinance in pamphlet form as provided by law.

Section 5. That is Ordinance shall be in full force and effect ten (10) days from and after its date of publication.

Section 6. In the event any section clause, provision or part of this Ordinance shall be found and determined to be invalid by a court of competent jurisdiction, all valid parts that are severable from the invalid parts shall remain in full force and effect.




