WHEREAS, the Mayor and City Council of the City of LeRoy have determined that for the best interest of the City and the administration of its police department that the use of the aforesaid police policy manual be terminated,

NOW, THEREFORE, BE IT ORDAINED, by the City Council of the City of LeRoy, in lawful meeting assembled, as follows:

Section 1. That portion of ordinance number 368, providing for adoption and use of the police policy manual dated September 1, 1979, specifically being Section 2 of the aforesaid Ordinance No. 368, is hereby repealed, the aforesaid police policy manual shall no longer be used by the City of LeRoy and its police department in the administration of the police department and in the administration, appointing, termination of appointments, and the like, of the Marshal and Police Chief of the City of LeRoy, and of the police officers and special police officers of the City of LeRoy.

<u>Section 2</u>. This ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form, as required by law
