#### **ORDINANCE NO. 02-01-02-41**

# AN ORDINANCE AMENDING CHAPTER 7, SEWERS, MUNICIPAL CODE OF LEROY, ILLINOIS, 1975 (AS AMENDED)

WHEREAS, the City Council of the City of Le Roy, McLean County, Illinois, an Illinois municipal corporation, hereinafter referred to as "CITY" has determined that it is necessary and in the best interests of the CITY and its residents, that the basic user rates for sewage disposal services be increased.

**NOW, THEREFORE, BE IT ORDAINED,** by the City Council of the City of Le Roy, in lawful meeting assembled, as follows:

**Section 1.** Chapter 7, Municipal Code of Le Roy, 1975 (as amended), Part 3, Article I, Section 3, and Ordinance Number 97, Section 3 of Article I of Part 3 thereof, are hereby repealed.

**Section 2.** Chapter 7, Municipal Code of Le Roy, 1975 (as amended), Part 3, Article I, Section 3, and Ordinance Number 419, Section 2 is hereby amended in words and figures as follows:

**Basic user rate:** There shall be and there is hereby established a minimum charge and basic user rate for the use of and for service supplied by the wastewater facilities of the CITY. There shall be a minimum charge of \$ 2.80 per one month period to all users whose water consumption does not exceed 1000 gallons per month period. There shall be a basic user rate of \$ 2.50 per 1000 gallons metered or adjusted (as set forth in Part 3, Article I, Section 3) in excess of 1000 gallons per one month period to all users who discharge normal strength wastes to the system effective with the first water meter reading after February 1, 2002.

**Basic user rate:** There shall be and there is hereby established a minimum charge and basic user rate for the use of and for service supplied by the wastewater facilities of the CITY. There shall be a minimum charge of \$ 3.25 per one month period to all users whose water consumption does not exceed 1000 gallons per month period. There shall be a basic user rate of \$ 2.90 per 1000 gallons metered or adjusted (as set forth in Part 3, Article I, Section 3) in excess of 1000 gallons per one month period to all users who discharge normal strength wastes to the system effective with the first water meter reading after February 1, 2003.

Basic user rate: There shall be and there is hereby established a minimum charge and basic user rate for the use of and for service supplied by the wastewater facilities of the CITY. There shall be a minimum charge of \$ 3.75 per one month period to all users whose water consumption does not exceed 1000 gallons per month period. There shall be a basic user rate of \$ 3.35 per 1000 gallons metered or adjusted (as set forth in Part 3, Article I, Section 3) in excess of 1000 gallons per one month period to all users who discharge normal strength wastes to the system effective with the first water meter reading after February 1, 2004.

Section 3. Effective February 1, 2005, sewer user fees will be increased based on the Consumer Price Index All Urban Customers (CPI-U). Any adjustment will be made effective with the first meter reading after February 1 and will be in effect for one year. The consumer price index inflation rate will be evaluated on an annual basis each February and adjustments will be made accordingly.

Section 4. Chapter 7, Municipal Code of Le Roy, 1975 (as amended), Part 3, Article I, Section 3, and Ordinance Number 97, Section 3 of Article I of Part 3 thereof, are hereby repealed.

**Section 5.** Chapter 7, Municipal Code of Le Roy, Illinois, 1975 (as amended), and Section 4 of Ordinance 419, are hereby amended by addition of new Section 4 of Article I, Part 3, Chapter 7, Municipal Code of Le Roy, Illinois 1975 (as amended), are hereby amended in words and figures as follows:

**Surcharge rate:** For waste strengths above normal strength of 200mg/BOD and 250 mg/TSS, a surcharge of \$ .35 per pound BOD and \$ .15 per pound SS shall be applied. The surcharge for each monthly period shall be computed by the following formula:

	X Y	=	one month average BOD concentration in mg/l. one month average SS concentration in mg/l
	A	=	one month metered water flow adjusted for appropriate losses in gallons.

**Section 6.** This ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as required by law.
