AN ORDINANCE AMENDING TITLE 8 WATER AND SEWER, CHAPTER 5 SEWER SERVICE FEES AND CHARGES FOR LONG TERM CONTROL PLAN SERVICE FEE OF THE MUNICIPAL CODE OF THE CITY OF LE ROY, ILLINOIS, 2003 (AS AMENDED)

WHEREAS, the Mayor and City Council of the City of Le Roy, McLean County, Illinois, an Illinois Municipal Corporation, have determined it is in the best interest of the City of Le Roy, and of its residents to amend Chapter 5 of Title 8, Water and Sewer by adding Section 10, Long Term Control Plan Service Fee, of the Municipal Code of the City of Le Roy, Illinois, 2003 (as amended), and

WHEREAS, the City of Le Roy is required to formally separate the existing combined sewer system by December 31, 2018 per the Illinois Environmental Protection Agency requirements, and

WHEREAS, the City of Le Roy must incur over \$2,000,000 in expenses to separate the existing combined sewer system and meet Illinois Environmental Protection Agency mandates,

NOW, THEREFORE, BE IT ORDAINED, by the City Council of the City of Le Roy, Illinois in a lawful meeting assembled, as follows:

<u>Section 1</u>. New Section 10 of Chapter 8, Water and Sewer, of the Municipal Code of the City of Le Roy, Illinois, 2003 (as amended) is hereby adopted in words and figures as follows:

- 10.01 <u>Combined Sewer Separation Requirements.</u> The anticipated expense to separate the existing sewer system will include the following Illinois Environmental Protection Agency mandates:
- A. Separation of the existing combined sewer system by December 31, 2018. The total estimated cost to complete this project is \$2,000,000.
- 10.02 Long Term Control Plan Service Fee. All utility customers of the City of Le Roy will be required to pay a \$13.00 dollar per month fee. This fee will begin on the first bill prepared after the 1st day of April, 2011 and will continue for no longer than 144 consecutive months (12 years) or upon repayment of all debt in relation to said project, whichever occurs first.

<u>Section 2.</u> All ordinances, or parts thereof, and all resolutions, or parts thereof, in conflict with this ordinance shall be and the same are hereby repealed to the extent of such conflict, and this ordinance shall be in full force and effect as set forth hereafter.

<u>Section 3.</u> Nothing in this ordinance hereby adopted shall be construed to affect any suit or proceeding pending in any court, or any rights acquired, or any liability incurred, or any cause or causes of action acquired or existing, under this ordinance; nor shall any just or legal right or remedy of any character be lost, impaired or affected by this ordinance.

<u>Section 4.</u> This ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as required by law.
