#### **ORDINANCE NO. 10-07-03-41**

# AN ORDINANCE AMENDING TITLE 8 WATER & SEWER; CHAPTER 4 SEWER USE AND SERVICE; SECTION 5 BUILDING SEWERS AND CONNECTIONS; OF THE MUNICIPAL CODE OF LE ROY, ILLINOIS, 2003

WHEREAS, the Mayor and City Council of the City of Le Roy, McLean County, Illinois, an Illinois municipal corporation, have reviewed the regulations for sewer use and service in reference to building sewers and connections; and

WHEREAS, the Mayor and City Council of the City of Le Roy have determined that regulations shall be established, being in the best interest of the city and its residents; and

WHEREAS, all things required by law, an ordinance to be done in regard to said regulations has been completed;

**NOW, THEREFORE BE IT ORDAINED,** by the City Council of the City of Le Roy, Illinois in lawful meeting assembled, as follows:

**SECTION 1.** That Title 8, Water & Sewer; Chapter 4 Sewer Use and Service; Section 5 Building Sewers and Connections; Subsection (J) Liability For Costs And Expenses for the Municipal Code of Le Roy, Illinois, is hereby deleted.

**SECTION 2.** That Title 8, Water & Sewer; Chapter 4 Sewer Use and Service; Section 5 Building Sewers and Connections; Subsection (J) Cost Borne by Owner for the Municipal Code of Le Roy, Illinois, is hereby added in word and figures as follows:

"COST BORNE BY OWNER: All costs and expenses including labor and materials incidental to the installation, connection and maintenance of a lateral sewer line shall be borne by the owner(s). The owner(s) shall indemnify the City from any loss or damage that directly or indirectly be occasioned by the installation, connection and maintenance of the lateral sewer lines. This section shall apply even where the lateral sewer line runs under a public street, public right-of-way, or easement."

**SECTION 3.** This ordinance shall be in full force and effect from and after its passage and approval as required by law.
