AN ORDINANCE AMENDING TITLE 8 WATER & SEWER; CHAPTER 4 SEWER USE AND SERVICE; SECTION 5 BUILDING SEWERS AND CONNECTIONS; OF THE MUNICIPAL CODE OF LE ROY, ILLINOIS, 2003

WHEREAS, the Mayor and City Council of the City of Le Roy, McLean County, Illinois, an Illinois municipal corporation, have reviewed the regulations for sewer use and service in reference to building sewers and connections; and

WHEREAS, the Mayor and City Council of the City of Le Roy have determined that regulations shall be established, being in the best interest of the city and its residents; and

WHEREAS, all things required by law, an ordinance to be done in regard to said regulations has been completed;

NOW, THEREFORE BE IT ORDAINED, by the City Council of the City of Le Roy, Illinois in lawful meeting assembled, as follows:

SECTION 1. That Title 8, Water & Sewer; Chapter 4 Sewer Use and Service; Section 5 Building Sewers and Connections; Subsection (K) "Payment Plan" for the Municipal Code of Le Roy, Illinois, is hereby added in word and figures as follows:

K. "PAYMENT PLAN": A monthly payment plan may be utilized as the means to assist in the payment of residents lateral sewer line installation cost. The Application and Agreement shall be executed prior to sewer line main connection.

SECTION 2. This ordinance shall be in full force and effect from and after its passage and approval as required by law.
