ORDINANCE

NO. 66

WHEREAS, the CITY OF LeROY has been granted a permit under the National Pollutant Discharge Elimination System (Permit No. IL 0021563) by the United States Environmental Protection Agency, Region V, and

WHEREAS, as a condition of said permit, the CITY OF LeROY is required to enact an Ordinance prohibiting the connection of industrial or domestic waste that does not meet certain requirements, such Ordinance to be enacted within 90 days of the effective date of the above Permit, and

WHEREAS, the CITY OF LeROY by this Ordinance intends to comply with the conditions of said Permit;

NOW, THEREFORE, BE IT ENACTED by the City Council of the CITY OF LeROY, Illinois, as follows:

- 1. After the passage of this Ordinance, no person within the City of LeRoy shall make any connection into the existing storm or existing field tile sewer system within the municipality's boundaries for the purpose of discharging industrial or domestic waste into said system, unless said industrial or domestic waste shall meet the requirements of Part 4 of the Regulations of the Illinois Pollution Control Board, Chapter 3.
- 2. If any person, firm or corporation shall violate the provisions of the preceding paragraph 1, the Mayor of the City of LeRoy shall direct the City Attorney to seek an injunction prohibiting such person, firm or corporation from making or using such connection.
- 3. The Superintendent of Streets of the City of LeRoy, Illinois shall be responsible for enforcement of this Ordinance. Said Superintendent shall prepare a program of enforcement to insure compliance with this Ordinance.

PASSED at a regular meeting of the City Council of the City of LeRoy, Ill. on the 1th day of November 1977 by a vote of 4 Ayes and 10 Nays.
