ORDINANCE NO. 307

AN ORDINANCE AMENDING CHAPTER 7, PART 2, ARTICLE III, SEC. 7, MUNICIPAL CODE OF LE ROY, 1975 (AS AMENDED), AND ORDINANCE NO. 97 OF THE CITY OF LE ROY, ADOPTED JUNE 4, 1979.

WHEREAS, the Mayor and City Council of the City of LeRoy, McLean County, Illinois, an Illinois municipal corporation, have determined that the availability of vitrified clay pipe is presently not as great as it was several years ago, and that an acceptable substitute product is generally available, and

WHEREAS, the Mayor and City Council of the City of LeRoy, McLean County, Illinois, have determined that it is in the best interests of the citizens to encourage the replacement of older sewer lines and sewer pipes, especially where necessary from time to time,

NOW, THEREFORE, BE IT ORDAINED by the Mayor and City Council of the City of LeRoy, in lawful meeting assembled, as follows:

Section 1. That Section 7 of Article III, Part 2, Chapter 7, Municipal Code of LeRoy, 1975 (as amended), being also the same section, article and part of Ordinance 97, be amended by addition of the following words after the words "Clay Pipe ASTM C-700 with C-425 flexible gasket joints," the following said words being prior to the period after the word "joints":

"or polyvinyl chloride (P.V.C.) pipe ASTM D-3034 (minimum standard dimension ratio (SDR) shall be 35) with solvent welded joints ASTM D-2855.

Section 2. This ordinance shall be in full force and effect from and after its passage and approval by publication in pamphlet form as required by law.
