AN ORDINANCE AMENDING ORDINANCE NO. 97, CHAPTER 7-SEWERS, MUNICIPAL CODE, LEROY, ILLINOIS 1975 (AS AMENDED)

WHEREAS, the Mayor and City Council of the City of LeRoy, McLean County, Illinois, an Illinois municipal corporation, adopted Ordinance No. 97. AN ORDINANCE ESTABLISHING SEWER USE AND RATES, on June 4, 1979, said ordinance being codified at Chapter 7 of the municipal code of LeRoy; and

WHEREAS, the Mayor and City Council of the City of LeRoy, have determined that it is in the best interests of the City and its residents to amend said ordinance to provide for minimizing the inflow of surface drainage waters into the combined sewer system and sanitary sewage treatment facility of the City of LeRoy,

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of LeRoy, Illinois, in lawful meeting assembled, as follows:

Section 1: Part 2., Article III of Ordinance No. 97-AN ORDINANCE ESTABLISHING SEWER USE AND RATES of the City of LeRoy, Illinois, adopted June 4, 1979, also being part of Chapter 7, Municipal Code, LeRoy, Illinois 1975 (as amended), is hereby amended by addition of new Section 13 at the end of the aforesaid Part 2., Article III-Building Sewers and Connections, said amendment to be in words as follows:

Sec. 13: All new construction tributary to the combined sewer system shall be designed to minimize or delay the inflow of the storm water contribution from the aforesaid new construction to the combined sewer system. Prior to any construction the owner of the premises upon which the aforesaid construction is proposed to take place shall submit, or cause to be submitted, to the City for approval a plan depicting how the owner proposes to accomplish the preceding requirement. Review by the City and approval on behalf of the City shall be accomplished by the City Engineer.

Sec. 2: This ordinance shall be in full force and effect after its passage, approval and publication in pamphlet form as required by law. PASSED by the City Council of the City of LeRoy. Illinois, on the 17th day of December , 1990.
