ORDINANCE NO. 818

AN ORDINANCE AMENDING ORDINANCE NO. 97, ALSO AMENDING CHAPTER 7-SEWERS, OF THE MUNICIPAL CODE OF THE CITY OF LEROY, MC LEAN COUNTY, ILLINOIS 1975 (as amended).

WHEREAS, the Mayor and City Council of the City of LeRoy, Illinois, an Illinois municipal corporation, find it is in the best interests of the residents of the City of LeRoy to amend Ordinance No. 97 and Chapter 7 of the Municipal Code of the City of LeRoy to provide for minimizing the inflow of polluted waters or other dangerous substances into the combined sewer system and sanitary sewage treatment facility of the City of LeRoy,

NOW, THEREFORE, BE IT ORDAINED, by the City Council of the City of LeRoy, Illinois, in lawful meeting assembled, as follows:

Section 1. Ordinance No. 97 -AN ORDINANCE ESTABLISHING SEWER USE AND RATES, and Chapter 7, SEWERS, of the Municipal Code of the City of LeRoy, Illinois, 1975 (as amended), ARTICLE III BUILDING SEWERS AND CONNECTIONS, is hereby amended by addition of new Section 12A, in words and figures as follows:

No person(s) shall make any connection of any garage floor drain to a building sewer or building drain which in turn is connected directly or indirectly to a public sanitary sewer. Prior to any construction, the owner of the premises upon which the aforesaid construction is proposed to take place shall submit, or cause to be submitted, to the City for approval a plan clearly depicting any floor drains intended to be installed in any garage, the outlet for any such drain(s), any treatment that will be made of the water before it reaches the outlet or at the outlet, and the path, as best as can be determined, of such water across the owner's land after reaching the outlet.

<u>Section 2</u>. The City Council hereby finds that all the recitals contained in the preambles and recitals to this ordinance are true, complete, and correct, and they hereby incorporate such preambles and recitals into this ordinance by this reference thereto.

<u>Section 3</u>. All ordinances, or parts thereof, resolutions, or parts thereof, in conflict with this ordinance shall be and the same are hereby repealed to the extent of such conflict, and this ordinance shall be in full force and effect as set forth hereafter.

Section 4. Nothing in this ordinance hereby adopted shall be construed to affect any suit or proceeding pending in any court, or any rights acquired, or any liability incurred, or any cause or

causes of action acquired or existing, under any act or ordinance hereby repealed; nor shall any just or legal right or remedy of any character be lost, impaired or affected by this ordinance.

Section 5. This ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form, as required by law.
