AN ORDINANCE AMENDING TITLE SIX – MOTOR VEHICLES AND TRAFFIC; CHAPTER TWO – TRAFFIC REGULATIONS; SECTION FIVE TRAFFIC REGULATIONS ON SPECIFIC STREETS OF THE MUNICIPAL CODE OF THE CITY OF LE ROY, 2003 (AS AMENDED)

WHEREAS, the Mayor and City Council of the City of Le Roy, McLean County, Illinois, an Illinois municipal corporation, have determined that the **alley** hereinafter described, located within the City of Le Roy, Illinois, is appropriate to be designated as one-way to be controlled by the installation of applicable signs for the purpose of regulating the provisions of Title Six, Chapter Two of the Municipal Code of the City of Le Roy, 2003 (as amended); and

WHEREAS, the City of Le Roy, by ordinance, may provide for the erection of signage such as one-way signs to control specific streets and right-of-way within the City of Le Roy:

NOW, THEREFORE, BE IT ORDAINED, by the City Council of the City of Le Roy, Illinois, in lawful meeting assembled, as follows:

Section 1. Motor Vehicles and Traffic, Traffic Regulations, Traffic Regulations on Specific Streets of the Municipal Code of the City of Le Roy, Illinois, 2003(as amended), is hereby amended in words and figures as follows:

Schedule E of Motor Vehicles and Traffic Regulations, Traffic Regulations on Specific Streets of the Municipal Code of the City of Le Roy, Illinois 2003(as amended), is hereby amended.

Section 2. This ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as required by law.

SCHEDULE E

ONE - WAY

- (a) The following **alley** located between East Center Street (radius) and South Chestnut Street and bounded by East Pine Street and East Center Street declared to be ONE-WAY.
- (b) All vehicles must access alleyway from South Chestnut Street traveling in a westerly direction and exit into the existing one-way radius of East Center Street.

SECTION 2. This ordinance shall be in full force and effect from and after its passage and approval as required by law.
