ORDINANCE NO. 317

AN ORDINANCE REPEALING ORDINANCE NO. 280

WHEREAS, the Mayor and City Council of the City of LeRoy, McLean County, Illinois, an Illinois municipal corporation, have determined that it is in the best intersts of the public and of the City of LeRoy that the alley running east and west, located in Block 70 of Conkling's Addition to the City of LeRoy, McLean County, Illinois, be opened to the passage of vehicular traffic in and out of said alley from the west end only, and whereas, the City of LeRoy has the authority to regulate vehicular traffic within its municipal limits,

NOW, THEREFORE, BE IT ORDAINED by the Mayor and City Council of the City of LeRoy, Illinois in lawful meeting assembled as follows:

Section 1. That Ordinance No. 280 adopted July 21, 1986, by the Mayor and City Council of the City of LeRoy, Illinois, is hereby repealed.

Section 2. That the alley running east and west located in Block 70 of Conkling's Addition to the City of LeRoy, McLean County, Illinois, is hereby declared open to vehicular traffic entering from and exiting from the west end only of such alley, and that such alley is hereby declared open to such traffic until further action shall properly be taken by the City of LeRoy to limit or terminate the use of said alley by vehicular traffic.

Section 3. This Ordinance shall be in full force and effect from and after its passage and approval and publication in pamphlet form as required by law.
