ORDINANCE NO. 463

AN ORDINANCE RE-NAMING CHAPTER 4-STREETS, DITCHES AND TREES, MUNICIPAL CODE OF LEROY, ILLINOIS, 1975 (AS AMENDED)
AND AMENDING SAID CHAPTER BY THE ADDITION OF SECTION 4.20
PROVIDING FOR REGULATIONS OF PLACEMENT OF OBSTRUCTIONS AND ENCROACHMENTS IN DITCHES ON CITY RIGHT-OF-WAY AND CITY PROPERTY

BE IT ORDAINED by the City Council of the City of LeRoy, in lawful meeting assembled, as follows:

Section 1. Chapter 4, "STREETS," Municipal Code of LeRoy, Illinois 1975 (as amended), is hereby retitled as follows:

STREETS, DITCHES, AND TREES.

<u>Section 2.</u> Chapter 4, "STREETS," Municipal Code of LeRoy, Illinois 1975 (as amended), is hereby further amended by addition of new Section 4.20 (Sections 4.15 thru 4.19 are hereby reserved for future use) in words and figures as follows:

4.20-DITCHES

- (a) It shall be unlawful for any person or persons to injure, obstruct, or place, throw, leave or caused to be placed or left any encroachment, obstruction, encumbrance, fill, or object in or upon any culvert or ditch, or to dump leaves, rock, gravel, trash, soil or other materials into any other culvert or ditch, located on any property of the City of LeRoy or in any street or alley right-of-way located within the City of LeRoy.
- (b) The Director of Public Works, upon written application, may approve, in writing, a plan for placement of culverts, driveway entrance aprons, erosion control structures, and the like, in any ditch on any City property or right-of-way located within the City of LeRoy when, in the discretion of the Director of Public Works, such structure, control facility, etc., is properly designed, and the placement of such is in the best interests of the City and the adjoining property owner(s) in order to control erosion, to permit adequate access to private property, or for such other good reason as may be shown in the application submitted to the Director of Public Works.
- (c) Any person or persons who shall place, leave or cause to be left, any encroachment, obstruction or encumbrance in or upon any culvert or ditch located on property of the City of LeRoy or on or adjacent to any street or alley right-of- way within the City of LeRoy, or any person or persons who shall injure or obstruct any culvert or ditch, as aforesaid, or any person or persons who shall dump leaves, rock, gravel, trash, soil or

other materials into any other materials into any other culvert or ditch, as aforesaid, shall in all cases be liable to the City of LeRoy and to private persons for all injury or damage arising therefrom.

<u>Section 3.</u> This ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as required by law.
