AN ORDINANCE AMENDING CHAPTER 4, SECTION 4.08, OF THE MUNICIPAL CODE OF LEROY, ILLINOIS, 1975 (AS AMENDED)

WHEREAS, the May or and City Council of the City of LeRoy, McLean County, Illinois, an Illinois municipal corporation, have determined it is in the best interest of the City and its residents to amend regulations adopted regarding excavations in streets or "street cuts" in addition to those already adopted by the City,

NOW, THEREFORE, BE IT ORDAINED, by the City Council of the City of LeRoy, in lawful meeting assembled, as follows:

<u>Section 1</u>. Sub-section (c) of Section 4.08, Chapter 4, Streets, Ditches and Trees, Municipal Code of the City of LeRoy, Illinois, 1975 (as amended), is hereby amended by addition of the following words and figures as follows:

The aforesaid bond shall not require a surety, unless so directed by the City Council at the request of the Director of Public Works. Further, all applicants for permits must give written proof to the Director of Public Works that the applicant has liability insurance coverage, naming the city as an additional insured, in minimum limits of \$250,000.00 per person, \$500,000.00 per occurrence, and \$50,000.00 property damage before a permit shall be issued. Such written proof of insurance may consist of a certificate of insurance or a certified true copy of the insurance policy, or other commonly accepted proof of insurance coverage.

- Section 2. All ordinances, or parts thereof, resolutions, or parts thereof, and in conflict with this ordinance shall be and the same are hereby repealed to the extent of such conflict, and this ordinance shall be in full force and effect as set forth hereafter.
- Section 3. This ordinance shall be in full force and effect from and after its passage and publication in pamphlet form as required by law.
