ORDINANCE NO. 859

AN ORDINANCE AMENDING CHAPTER 4 - STREETS, DITCHES AND TREES, SECTIONS 4.15, 4.16 AND 4.17, MUNICIPAL CODE OF THE CITY OF LE ROY, ILLINOIS, 1975 (AS AMENDED), AND AMENDING ORDINANCES NO. 481 AND 497 OF THE CITY OF LE ROY, ILLINOIS

WHEREAS, the Mayor and City Council of the City of LeRoy, McLean County, Illinois, an Illinois municipal corporation, have determined that it is in the best interests of the City of LeRoy and its residents that certain regulations regarding trimming of trees and tree trimmers be amended or adopted in order to enhance the health, safety and welfare of the residents of the City of LeRoy, Illinois,

NOW, THEREFORE, BE IT ORDAINED, by the City Council of the City of LeRoy, Illinois, in lawful meeting assembled, as follows:

<u>Section 1</u>. Subsection (c) of Section 4.15 TREE TRIMMERS, of Chapter 4, Streets, Ditches and Trees, of the Municipal Code of the City of LeRoy, Illinois, 1975 (as amended) is hereby repealed.

<u>Section 2</u>. New subsection (c) of Section 4.15 TREE TRIMMERS, of Chapter 4, Streets, Ditches and Trees, of the Municipal Code of the City of LeRoy, Illinois, 1975 (as amended) is hereby adopted in words and figures as follows:

4.15 [TREE TRIMMERS]

- (c) <u>Regulations To Be Obeyed</u>. In trimming trees the following regulations shall be complied with:
 - (1) All applicable state and federal regulations and laws.
- (2) Regulations adopted by the Administration of the City of LeRoy under authority hereby granted to establish reasonable rules and regulations for the removal of trees on private property when the removal of said tree or trees may require placement of limbs, cuttings, wood or other debris on City right-of-way for pickup or other disposition by the tree trimmer, or when City right-of-way shall be required, in the interests of public safety, to be blocked or barricaded for a period of time to facilitate the removal of one or more trees on private property.
- <u>Section 3</u>. Section 4.16 TREES ON CITY RIGHT-OF-WAY, of Chapter 4, Streets, Ditches and Trees, of the Municipal Code of the City of LeRoy, Illinois, 1975 (as amended) is hereby repealed.
- <u>Section 4.</u> New Section 4.16 TREES ON CITY RIGHT-OF-WAY, of Chapter 4, Streets, Ditches and Trees, of the Municipal Code of the City of LeRoy, Illinois, 1975 (as amended) is hereby adopted in words and figures as follows:
- 4.16 TREES ON CITY RIGHT-OF-WAY. No person or entity shall cut or trim any tree or shrubbery on City right-of-way unless such person or entity shall have been contracted with by the City of LeRoy to do such work, or unless such work shall otherwise be done with the consent of the Administration of the City of LeRoy.
- Section 5. Section 4.17 REMOVAL AND DISPOSAL OF TREES OR WOODY PLANTS CUT ON PRIVATE PROPERTY, of Chapter 4, Streets, Ditches and Trees, of the Municipal Code of the City of LeRoy, Illinois, 1975 (as amended) is hereby repealed.

Section 6. New Section 4.17 REMOVAL AND DISPOSAL OF TREES OR WOODY PLANTS CUT ON PRIVATE PROPERTY, of Chapter 4, Streets, Ditches and Trees, of the Municipal Code of the City of LeRoy, Illinois, 1975 (as amended) is hereby adopted in words and figures as follows:

4.17 REMOVAL AND DISPOSAL OF TREES OR WOODY PLANTS CUT ON PRIVATE PROPERTY

- a. The Administration of the City of LeRoy shall promulgate written regulations to establish reasonable rules and regulations for the removal of trees or other woody plants or brush on private property when the removal of said tree, trees, woody plants, or brush, may require placement of limbs, cuttings, wood or other debris on City right-of-way for pickup or other disposition, or when City right-of-way shall be required, in the interests of public safety, to be blocked or barricaded for a period of time to facilitate the removal of one or more trees on private property.
- b. Any tree, woody plant or other brush cut or trimmed by a homeowner on or from private property and then placed for pickup by the City, such placement being required to be on City right-of-way or near a curb, will be removed by the City in the manner most appropriate, including chipping of the tree, woody plant, brush and other disposable plant material, said chipping to be done at the rate of \$25.00 per hour, with a minimum one hour charge.
- <u>Section 7</u>. All ordinances, or parts thereof, and all resolutions, or parts thereof, in conflict with this ordinance shall be and the same are hereby repealed to the extent of such conflict, and this ordinance shall be in full force and effect as set forth hereafter.
- <u>Section 8</u>. Nothing in this ordinance hereby adopted shall be construed to affect any suit or proceeding pending in any court, or any rights acquired, or any liability incurred, or any cause or causes of action acquired or existing, under any act or ordinance hereby repealed as cited in Sections 1,3 and 5 of this ordinance, nor shall any just or legal right or remedy of any character be lost, impaired or affected by this ordinance.
- <u>Section 9</u>. This ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as required by law.
